Trustee Ribeiro questions about the legal counsel contract. Carolyn Kone and Jerry Sagnella discussed with the Trustees that Corporation Counsel has recently stated they will not review the contract and the fund will need another legal counsel selected by the Trustees to review the contract. The Trustees requested that the Brenner, Saltzman & Wallman contract be placed on next month's Agenda (for both Boards) to be reviewed by the Trustees, who will then decide if another legal counsel review will be necessary.

**ITEM 9. OLD BUSINESS:**

Trustee Cannon: one year ago a plan was initiated with the pension that if the city were to enter in from that point on with anyone in particular, that would be something the city would have to work out with the individual, and the city would be responsible in the form of an annuity or some arrangement. The pension will have to understand the terminology of how it will happen and the ramifications if that request was to receive a pension based on an arrangement with the city; those numbers should be vetted through an actuary. One particular case, with Ricci, could possibly send a request to the actuary to run the numbers based on the arrangement to see what the city would be looking at and what the pension board would collect if it went through. Carolyn Kone stated it would not be the pension board collecting. In the past, if there is a special arrangement with an employee retiring, they receive the pension they would have received, and the city pays them separately the present value of the bump up in their pension. The actuary must get involved to see what that present value is with the increase; Carolyn suggests that request must come from the City, either Mr. Gormany or Cathleen Simpson. Trustee Mayor Elicker said he will connect with Mr. Gormany on the request.

**ITEM 10. NEW BUSINESS:**

- A.** Pension Administrator Leanna Ambersley discussed that in-person retirement interviews will be moving to either virtual (Zoom) or phone interviews for employees to submit retirement packet information. Currently working on a way to submit Worker's Comp payment checks.
- B.** Trustee Cannon requested an extension on the Military Buy Back for the Fire Dept until COVID-19 is behind us. Leanna Ambersley stated that is a decision that needs to be made by Labor Relations. Forms can still be submitted by email until the deadline. Trustee Cannon stated his concern is members getting access to their DD214 in time. Carolyn Kone stated it needs to be an MOU with Labor Relations because it is a Plan Provision. Trustee Mayor Elicker requested Leanna Ambersley email Labor Relations Director and cc the Mayor on the email.
