**STANDARD CONDITIONS OF APPROVAL**

1. Pursuant to State Statute, this site plan and soil erosion and sediment control plan approval is valid for a period of five (5) years following the date of decision, until July 18, 2023. Upon petition of the applicant, the Commission may, at its discretion, grant extensions totaling no more than an additional five (5) years to complete all work connected to the original approval.
2. The applicant shall record on the City land records an original copy of this Site Plan Review report (to be provided by the City Plan Department) and shall furnish written evidence to the City Plan Department that the document has been so recorded (showing volume and page number), prior to City Plan signoff for building permits. A digital copy of the recorded site plan shall be provided to staff (.pdf).
3. Upon approval by the City Plan Commission, provide compiled digital copies of all application materials, including drawing sets and reports, to staff for filing (.pdf files) prior to City Plan signoff.
4. Comments under **ADDITIONAL CONDITIONS OF APPROVAL** shall be reviewed with the City Plan Department and resolution reflected on final plans, prior to their circulation for signoff.
5. Signoff on final plans by the City Engineer; Department of Transportation, Traffic, and Parking; City Plan Department; and Fire Marshal in that order shall be obtained prior to initiation of site work.
6. Any sidewalks or curbs on the perimeter of the project deemed to be in damaged condition shall be replaced or repaired in accord with City of New Haven standard details.
7. As-built site plan shall be filed with City Plan Department, with a copy to the City Engineer, prior to issuance of Certificate of Occupancy. Site Plan shall be submitted in mylar and digital form (.pdf).

#### **BACKGROUND**

##### **Previous CPC Actions:**

- CPC 1541-01: Site Plan Review for the construction of 5 bike share stations within the public right-of-way in various locations for the third phase of the City of New Haven bike share system. Approved February 21, 2018.
- CPC 1542-05: Site Plan Review for the construction of 3 bike share stations and revisions to one previously approved station within the public right-of-way in various locations for the fourth phase of the City of New Haven bike share system. Approved March 28, 2018.

**Site description/existing conditions:**

The proposed project is for the construction of 10 bike share stations for the first phase of New Haven Bike Share's Expansion Project. Bike share stations proposed in previous CPC applications are located in Dixwell, Newhallville, Downtown, Fair Haven, the Hill, WEB, and East Rock neighborhoods. The proposed bike station locations for the first phase of the Expansion Project of the New Haven Bike Share system include the Hill, Westville, Newhallville, Fair Haven and Downtown along Dixwell Avenue in the north, Chapel Street in the east, Ella T. Grasso Boulevard in the south and Whalley Avenue in the west.

**Proposed activity:**

System users will be able to unlock a rented bicycle from a rack using a mobile app, ride it to their destination, and re-lock it at a different station. The site will include several bike racks for locking bike share bicycles, an informational aluminum sign, and a solar-powered ad panel. The racks and sign will be bolted directly into concrete. The ad panel will require an installation of a foundation and, in some cases, a concrete pad will need to be poured.

**Motor vehicle circulation/parking/traffic:**

No parking spaces will be altered.

**Bicycle parking:**

Each proposed station will have space for between five and nine bicycles. Although docking spaces will be located on existing sidewalks, locations have been chosen to ensure that a minimum five-foot width for pedestrian access will be maintained while the bikes are docked.

**Signage:**

Each station will have two signs. One sign will be an approximately 3' x 2' informational sign that will include system instructions and maps. The other sign will be approximately 8' x 5' double-sided solar-powered advertising panel.
