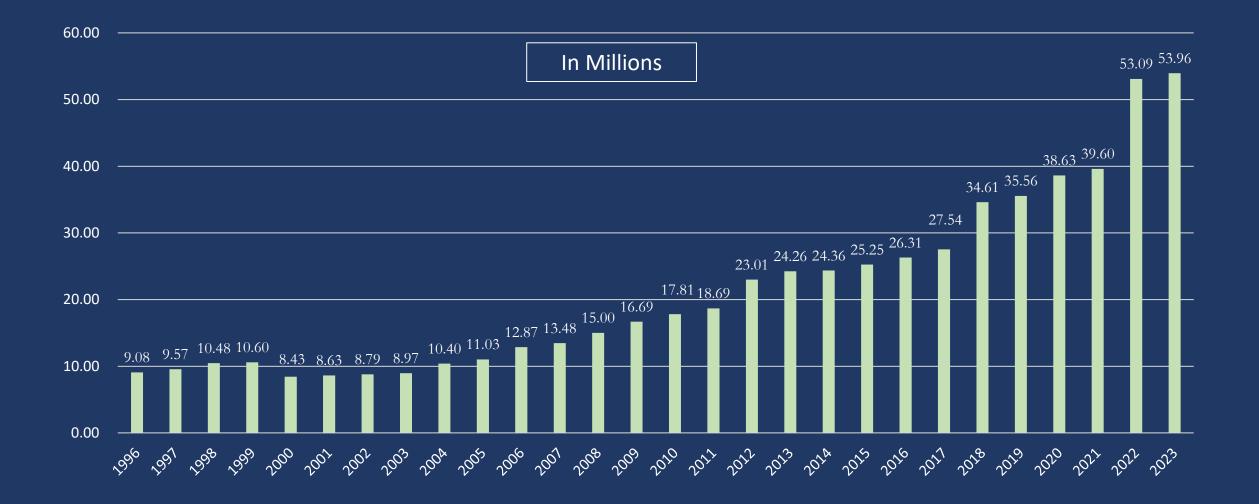

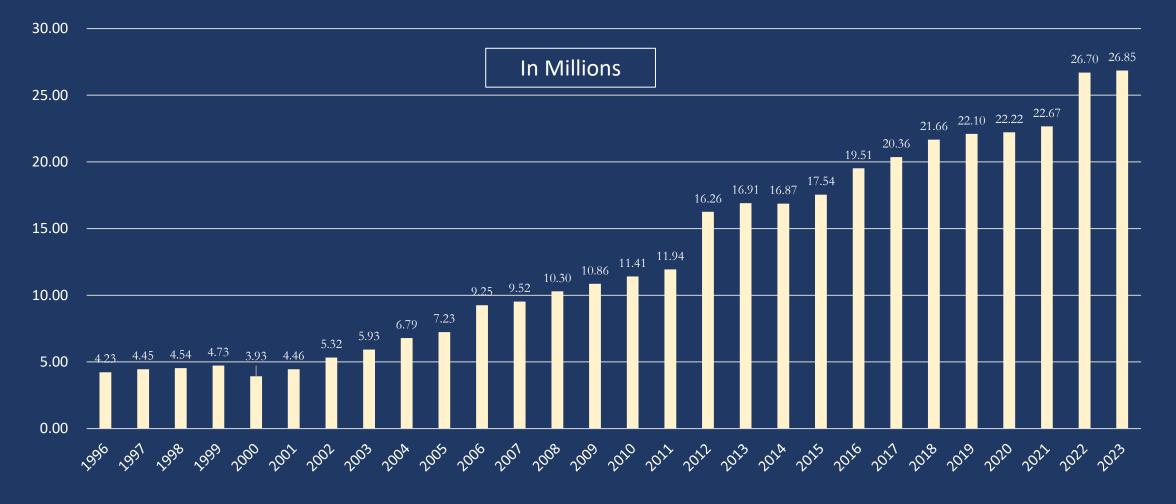

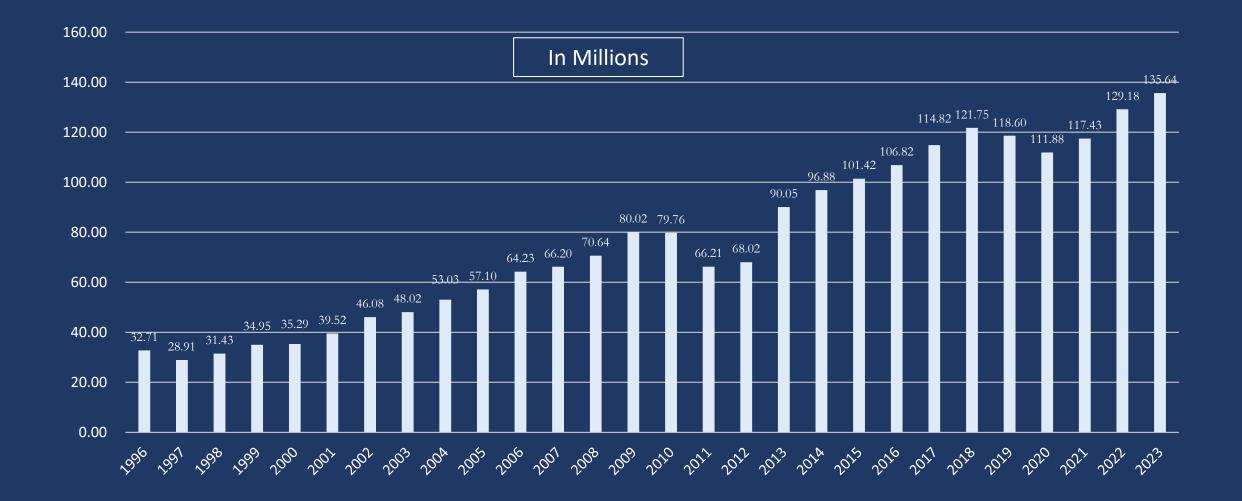
#### Police and Fire Pension Contribution History



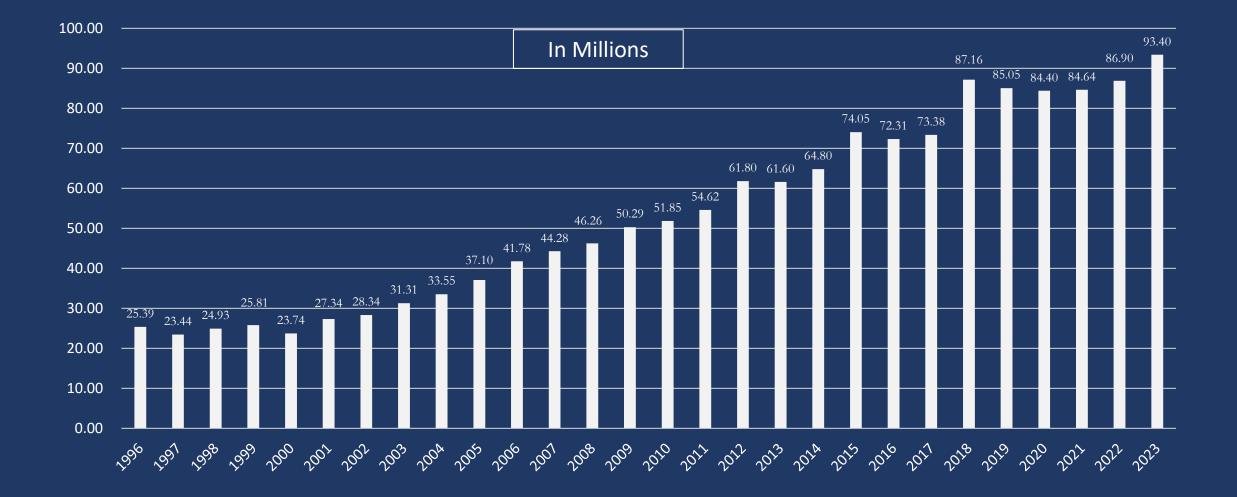
## **CERF** Pension Contribution History



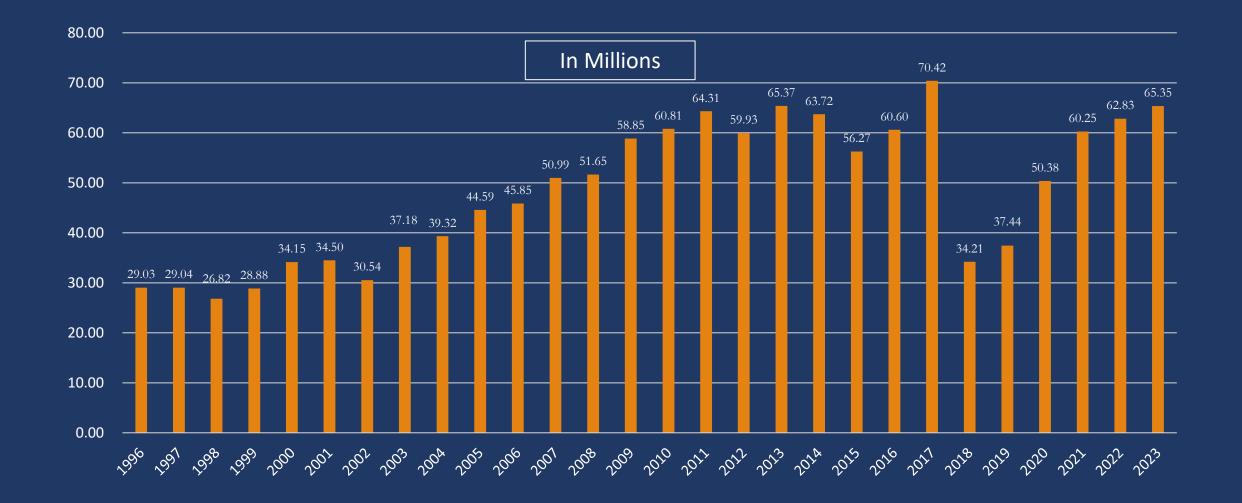
## Medical Payment History

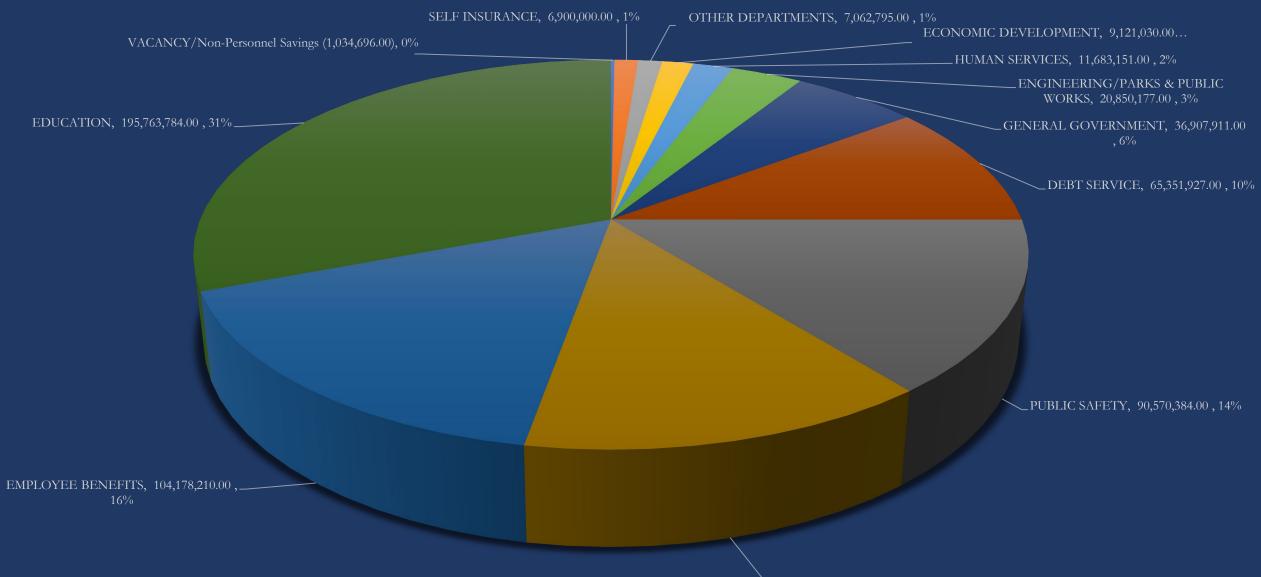

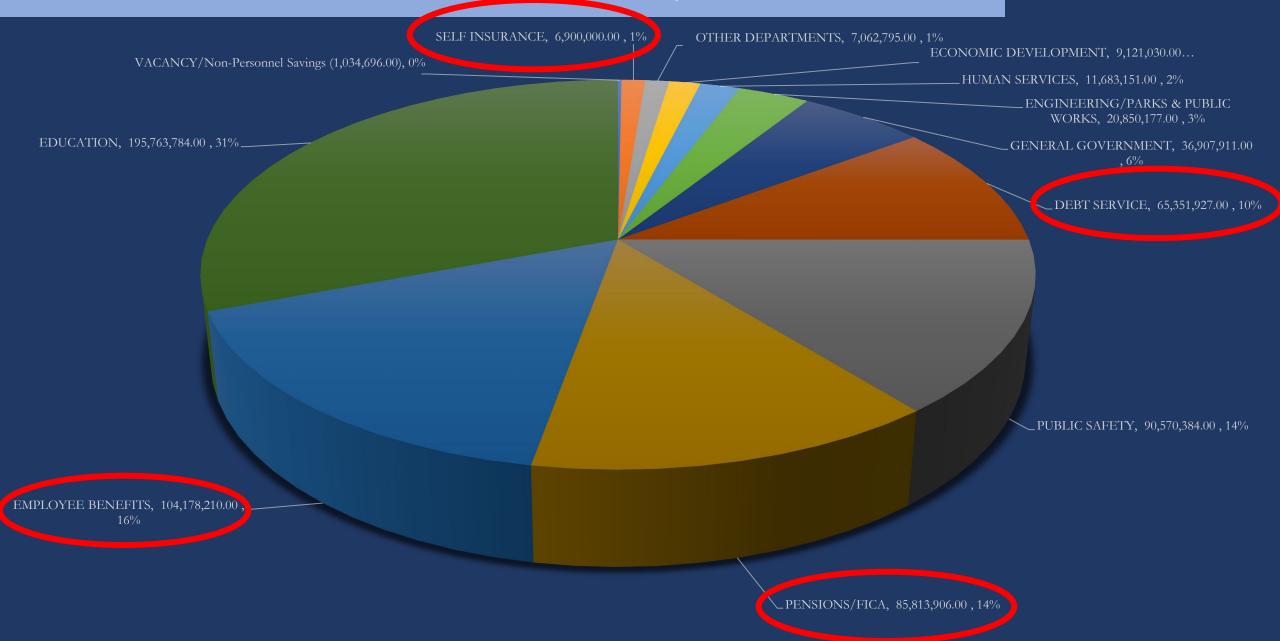

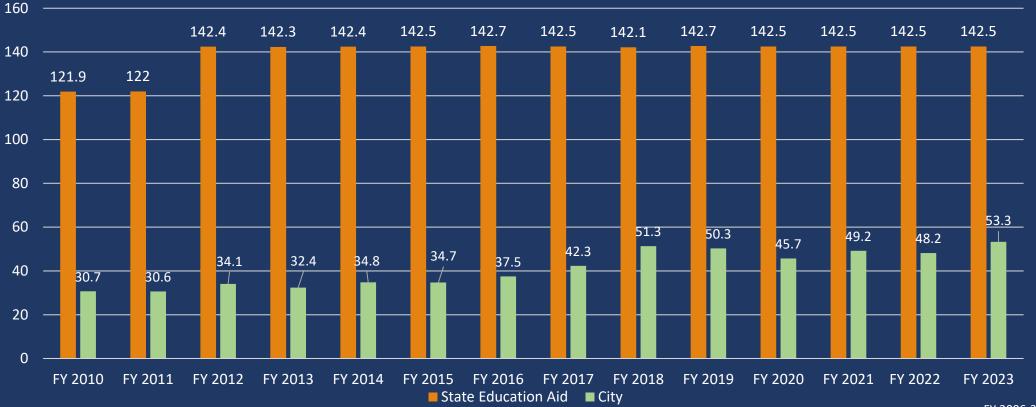


# Summary of Expenditure changes

- Fixed Cost Increases account for <u>48.13% of budget increase</u> -
  - Medical contribution \$6.5M
  - CERF and Police and Fire Pension Fund Contribution \$1.0M
  - Debt service \$2.5M
  - General liability insurance \$800K
  - City utilities \$1.3M
  - Fire Services (local 825) contractual wage increases \$530K
  - Increased Workers Compensation by \$300K
- Other Expenditure Increases / Decreases -
  - Police overtime \$1.4M increase; Fire Services overtime \$200K increase
  - Increase in salary reserve \$800K
  - Eliminated expenditure reserve (\$2.3M)

## Board of Education Budget and Aid

- Based on Governors Biennial Budget -
  - Education Cost Sharing remains flat at \$142.5M
  - Alliance grant increased in FY 2023 to \$20.9M (from \$20.3M)
  - Funding of ESSRF Federal Grant
  - Increase of \$5.0M in Board of Education budget.

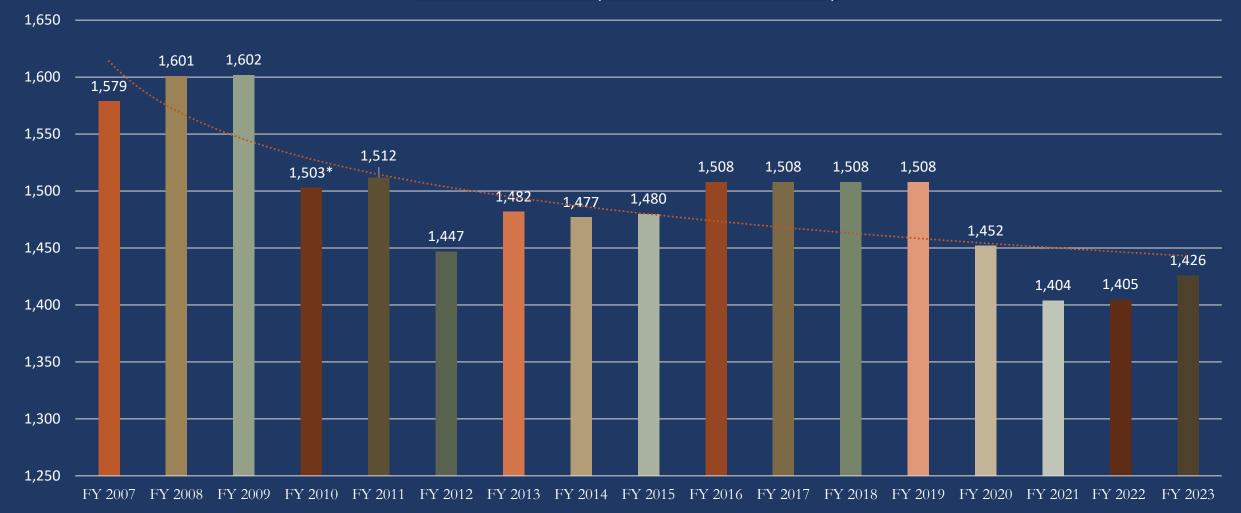

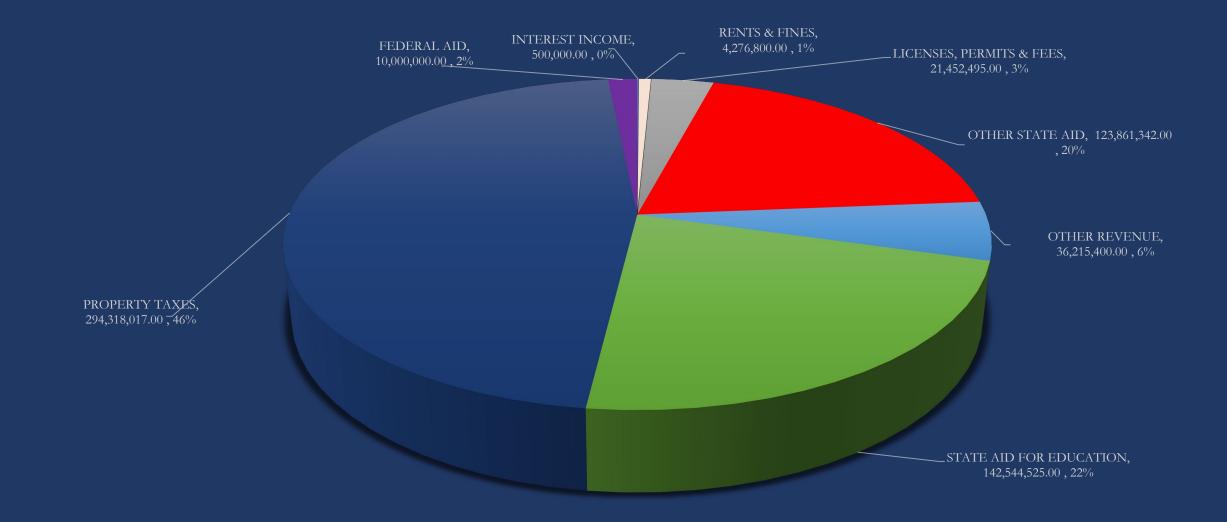

#### FTE 2007 – 2023 (FT + Dollar Positions)



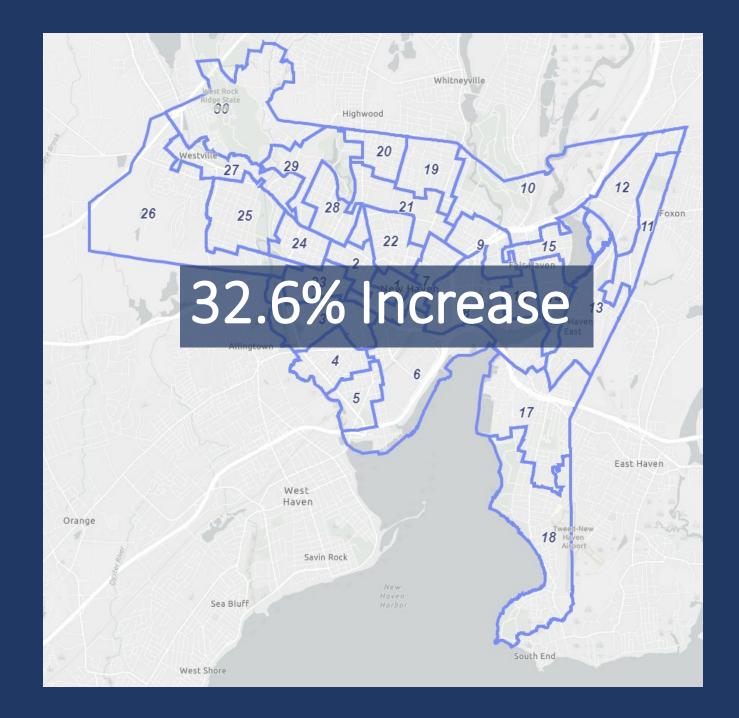
#### FY 2022-23 General Fund Revenue



# Summary of Revenue changes

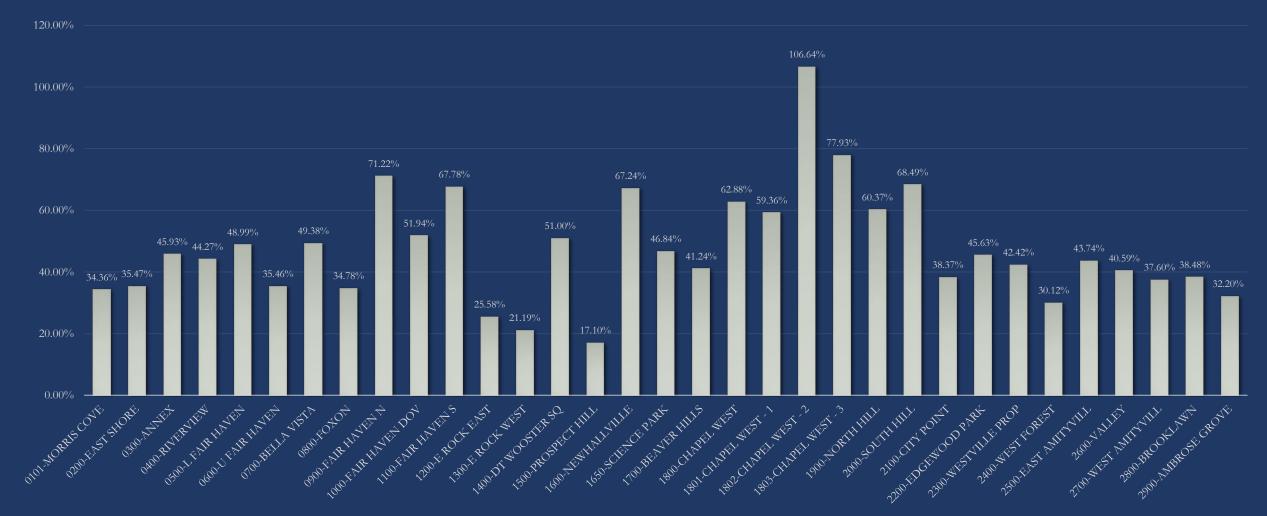
- · Overall revenue budget increase of \$26.8M (4.42%), compared to last year's budget -
  - Tier PILOT \$49M and Additional contribution from Yale University in the amount of \$10M
  - Motor vehicles property tax grant of \$7.7M added per governors recommended municipal aid budget
  - Building permits budget increased from \$13.7M to \$15.0M
  - Meter receipts reduced from \$4.5M to \$3.7M
  - Parking tags reduced from \$4.1M to \$3.8M
  - New Haven Parking Authority PILOT Payment reduced from \$2.8M to \$1.5M
  - Sale of fixed assets increased from 1.0M to 2.5M
  - Added in Federal Aid Public Health, Economic Stabilization and Recovery to assist with the City long term economic recovery of \$10.0M.

Average Property Value Change %



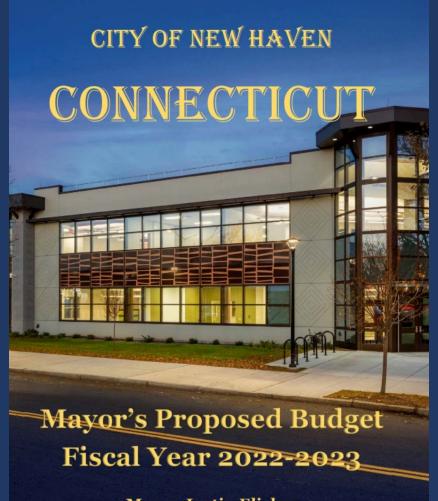
