AGENDA:

- I. Call to Order & Attendance at 6:08pm. Chair Rodriguez was detained so this meeting was chaired by Vice Chair William Wynn.
- II. Approval of prior meeting minutes. Moved by Bhandary-Alexander 4-0-0.
- III. There was no Public Comment made.
- IV. Report from the Chair (Vice Chair Wynn deferred to Administrator Heimer for this agenda item)
 - A. Conference invite for Public Finance Program Administrators in Albuquerque, NM
 - 1. The Board had a discussion about how many individuals should attend this event, and what a reasonable expectation of cost to The Fund would be. Payment for this trip, including travel, hotel, and a per diem would be paid from the Board's discretionary spending account for fiscal year 2021-2022 until the cap of \$5,500 was met. Any overage could be paid in fiscal year 2022-2023. The Board will set a 2022-2023 discretionary spending budget at the June meeting.
 - O'Connell adamantly supported the idea of attending over Zoom. The Administrator and Board
 Members highlighted the value of in-person learning, communication and networking. The
 conference in questions will host public finance officials and program managers from across the

country from all levels of government and multiple styles of organization. The benefits to attending are particularly important in a year when the board is considering ordinance revisions.

V. Administrator's Report

A. 2021 Overage Deposits

Both campaigns from the 2021 election cycle submitted overages to be deposited by the Finance
Department but neither has been completed. The Carlson campaign has been particularly vocal
about this and requested that the board follow up. Chair Rodriguez made a call to Michael
Gormany, head of the department, during the meeting and asked for a status update.

B. RFQ draft

- Language from the previous RFQ was distributed to the Board Members. Members will hold an
 executive session at the June meeting to discuss this hiring and staffing question.
- C. Press Inquiries and Public Outreach for Ordinance Revision
 - The Administrator received requests to discuss possible changes to the NHDF ordinance with NPR
 and The New Haven Independent. These requests will be put on hold until after the conference in
 July the Board wants to complete a draft of changes before discussing them with the press and
 presenting concepts to the community.

VI. Ordinance Review Sub-Committee (Bhandary-Alexander, chair)

- A. Ordinance draft (tabled from 4/20/22)
 - The draft created by the subcommittee is complete. The Board members, particularly
 Bhandary-Alexander and Goode want to see what conversations, ideas, and exchanges occur at
 the Administrators Conference in Albuquerque before submitting a draft to the Board of Alders for
 workshopping.

VII. New Business

A. An Executive Session will kick off the meeting in June to discuss the RFQ and other matters relating to personnel/staffing.
