

TRAFFIC AUTHORITY MINUTES  
MAY, 2022

The Traffic Authority of the City of New Haven, duly warned, met in Chambers, One Union Avenue, New Haven, Connecticut on, May 10th 2022.

The meeting was called to order at 6:01 PM, Commissioner Ribeiro presiding.

The minutes of the October, 12th, 2021 and March 8th, 2022 meetings were reviewed. Commissioner Walker moved to approve the minutes. Commissioner Lawlor seconded the motion. The motion was voted on and approved by a unanimous vote.

The following items were presented:

Item 1. Request of Kampton Singh, Alder, Ward 5, for establishing TWO HOUR PARKING 8AM-7PM, MONDAY-SATURDAY regulation of the north side of Lamberton Street from Arthur Street to Dewitt Street and on the south side from Plymouth Street to Greenwich Avenue. Approval recommended.

Bruce Fischer presented the technical report. Commissioner Lawlor moved to approve the item. Commissioner Walker seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 2. Request of Kampton Singh, Alder, Ward 5, for establishing NO PARKING regulation of the south side of Lamberton Street from Greenwich Avenue to Kimberly Avenue. Approval recommended.

Bruce Fischer presented the technical report. Commissioner Lawlor moved to approve the item. Commissioner Walker seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 3. Request of the Department of Transportation, Traffic and Parking for parking controls in areas less than one block in length as indicated below be approved.

C. Establish NO PARKING regulation.


1. On both sides of Dewitt Street, From Lamberton Street to 225 feet north of Lamberton Street (request of Kampton Singh, Alder, Ward 5).
