## REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE NEW HAVEN SOLID WASTE AND RECYCLING AUTHORITY

A regular meeting of the New Haven Solid Waste and Recycling Authority (the "Authority") was held on June 9, 2022, at 6:02 p.m. online via Zoom Video Conference call.
