#### **Minutes**

0.0 J. Huettner called the meeting to order with introductions.

1.0 Approval of November 8, 2018 Meeting Minutes was unanimous.

#### **NEW BUSINESS**

- 2.0 Election of Officers: There was a motion by consensus to maintain the existing officers for 1 year: J. Huettner Chair, N. Hogan Co- Chair, V. Wilson Parliamentarian. Motion unanimously carried.
- 3.0 Housing Not Hand Cuffs: J. Huettner encouraged commissioners to really read through this article. There was concern for the poor follow up by the administration on the proposed Bill of Rights and the Resolution to Decriminalize Homelessness. It was suggested that the article: Housing Not Hand Cuffs be forwarded to Corporation Counsel to add context to the proposed Bill of Rights and Resolution for Decriminalization. It was agreed that there needs to be a shift mindset regarding the homeless; a review of how laws are being applied to the homeless; and a review of data collection on police interactions with the homeless. This commission would like to meet with the police leadership on these matters.
- 4.0 Forum for Elderly Homeless Individuals: This commission is concerned about the growing number of elderly individuals who are experiencing homelessness. Consequently they are planning to host a forum on the

topic. The group agreed to use a portion of the January meeting to further plan for a February Forum on Elderly Homelessness. The plan is to invite shelter providers, Department on Aging, City's Elderly Services Department, HANH, Cornell Scot Hill Health Center, Yale New Haven Hospital, BH Care, and elderly homeless individuals.

- 5.0 Affordable Housing Taskforce: A. Roth shared that the deadline for all affordable housing proposals was 11/30/18. In addition there will be 2 public hearings for feedback on the proposals received.

  V. George shared an excerpt of CAN affordable housing proposal which included inclusionary zoning, increased Single Room Occupancy units, and auxiliary housing.
- 6.0 Homeless Shelter Counts: V. George shared that the Columbus House Overflow shelter opened November 19<sup>th</sup>, and maintained a nightly average of 60 guest. During the month of November there was an average of 304 single individuals, 26 youth (ages 18 24)and 43 families served. During the Governor's Family Challenge, New Haven county placed 43 families in permanent housing which exceeded their goal of 40.
