- II. Review of the Minutes from January 18, 2023, motion to approve by Bhandary-Alexander. 3-0-0
- III. Public comment Sarah Ficca joined the meeting, who has been submitted as a new board member by Mayor Elicker and will appear before the Aldermanic Affairs committee on February 27th. Ficca mentioned that she appreciates the work of the Board and looks forward to supporting ongoing efforts to expand the program's use in the city.
- IV. Chair's Report
 - A. Renewing membership, meeting on February 27th Chair asks for attendance in person to address any questions the Alders may have. Administrator Heimer will also plan to attend.
 - B. New members proposed are Sarah Ficca, who was in attendance, and Lesley Heiffel-McGuirk.

V. Administrator's Report

A. 2023 Election Update

- Participating candidates Justin Elicker and Shaffiq Adubassur have submitted the candidate contract and affidavit and shown intent to use the Fund. The Elicker campaign anticipates filing their first matching funds and grant request this coming week.
- Other campaigns and committees Three other candidates either in active or
 exploratory phases. A training has been requested by the Liam Brennan campaign
 and will likely take place in the coming weeks virtually.
- B. Summer Internship After board members were given the opportunity to review the description of the summer internship the following motion was made by James Bhandary-Alexander:
 - Motion to approve the summer internship program and pay a contract total of up to \$5,000 for the completion of projects, as outlined in the description. 4-0-0
 - Motion to authorize the finance department to make any necessary payments and cover any costs associated with paying an intern including but not limited to secondary costs associated with hiring people through the city. 4-0-0.
- VI. Report from the Ordinance Review Sub-Committee (James Bhandary-Alexander, Chair) The legislation is being held by the Legislative Affairs Committee as charter revision is taking a front seat. It is most likely that the Democracy Fund will appear on the agenda in April at the earliest. As this legislative proposal will not take effect until the completion of the current election cycle (likely January 1, 2024 active date) this is well within the reason of timely action by the committee.
- VII. New Business Administrator Heimer will complete training for new Board Members after their official appointment.

The Entire Board wished to thank Board Members William Wynn for his years of dedicated service to the New Haven Democracy Fund and regrets his departure from the board, solely due to a restriction in municipal statute limiting board member's terms to 9 years.
