A regular meeting of the New Haven Solid Waste and Recycling Authority (the "Authority") was held on January 12, 2023, at 5:30 p.m. online via Zoom Video Conference call.

Rose Bonito began the meeting at 5:34 p.m. with the approval of the minutes from the September 8, 2022, October 13, 2022, November 10, 2022 and December 8, 2022 regular meetings and September 27, 2022, October 19, 2022, November 16, 2022 and December 13, 2022 special meetings, seconded by Victor Fasano. There was no old business.


Under new business Mr. Fasano suggested the Board of Directors have a dinner to thank Pierre for his many years of leadership.

A regular meeting of the New Haven Solid Waste and Recycling Authority (the "Authority") was held on February 9, 2023, at 5:30 p.m. online via Zoom Video Conference call.

Rose Bonito began the meeting at 5:35 p.m. with the Treasurers' reports as the was no quorum for items 2 and 3.

Pierre Barbour presented the treasurers reports for the month of January 2023. He noted that the report reflected an increase in revenue based on vendors prepaying for tonnage and the November City payment.

Mr. Barbour presented the tonnage reports for the month of January 2023. There was a significant increase in January's MSW tonnage then the previous year. He will report findings at March's meeting.

Item 5 was tabled as well.

Mr. Barbour discussed the need to stabilize the wall as the deterioration has become a hazard to users of the facility. He has had a conversation with the Public Works Director and recommended that the area be closed off until repairs are made. A consequence would be a higher level of illegal dumping around the City. So, the alternative is to shuffle the containers to another section of the transfer station to allow materials to come in.

Under new business Mr. Barbour indicated that it may be a good time for the Authority to pursue hiring its own scale operating/gate staff instead of relying on the Public Works staff.

There was no old business.

There were no public comments.

Ms. Targove made a motion to adjourn the meeting, seconded by Mr. Fasano.

Rose Bonito began the meeting at 5:34 p.m. with the Treasurers' reports as the was no quorum for items 2 and 3.

Pierre Barbour presented the treasurers reports for the month of February 2023. He noted that the report reflected the Authority's first payment to the Executive Director search firm and the Authority's insurance renewals with HD Segur.

Mr. Barbour presented the tonnage reports for the month of February 2023. The haulers MSW increased and the City's MSW was steady. Recycling tonnage is tracking along the same data from the prior year.

Items 6 and 8 were tabled as well.

Mr. Barbour informed the Directors that Fuss and O'Neil had reviewed the wall condition at the Citizen drop-off and has recommended a weight restriction be enacted to help mitigate any further decline of the area until the new wall can be constructed.

Mr. Barbour received a short list of candidates from the search firm and will be scheduling interviews soon and make recommendations to the Board shortly.
