

WHEREAS, the City of New Haven (the "City") and AFSCME Local 884 (Clerical Union) (the "Union") are parties (collectively the "Parties") to that of certain collective bargaining agreement entitled Agreement Between the City of New Haven and AFSCME Local 884 (Clerical Union); and

WHEREAS the collective bargaining agreement between the Parties had expired by its terms on June 30, 2020; and,

WHEREAS, the Parties, over the course of several rounds of negotiation, negotiated to secure a successor Collective Bargaining Agreement: and

WHEREAS the Parties reached a tentative agreement entitled Collective Bargaining Agreement Between The City of New Haven and AFSCME Local 884 (Clerical Union), July 1, 2020 - June 30, 2025 (the "2020-2025 Agreement"); and

WHEREAS in accordance with the Municipal Employee Relations Act, Section 7-474(b), the 2020-2025 Agreement must be submitted to the municipal legislative body within fourteen (14) days from that date of the agreement. WHEREAS the Union ratified the Tentative Agreement on April 25th, 2023, requiring the Office of Labor Relations to submit the Tentative Agreement to the regular agenda of the Board of Alders by no later than May 15<sup>th</sup>, 2023 in order to be placed on the agenda for the Board of Alders meeting; and

WHEREAS Labor Relations is still bound by the 45 day statutory timeline for legislative approval; and

WHEREAS failure by the local legislative body to approve or reject said 2020-2025 Agreement within these prescribed time limits shall automatically make the Agreement legally valid and binding upon the City of New Haven. Dear President Walker-Myers;

The City of New Haven (the "City") through its Economic Development Administration ("EDA") and New Haven Free Public Library ("NHFPL"), Concepts for Adaptive Learning ("CfAL") and Elm City Communities ("ECC") to propose to partner with respect to the application for a grant in the amount of \$277,617.00 from the Federal Communities Commission (the "FCC Grant") that would be used to fund a series of events to assist residents of the City with signing up for the Affordable Connectivity Program, which program provides a federal subsidy for household internet bills (the "ACP"). The ACP is the cornerstone of the City's approach to enhancing equitable accessible to high-speed internet for the benefit of all residents of the City, providing a \$30.00 per month subsidy to qualifying households towards an internet access plan, together with a one (1) time \$100 benefit to qualifying households for device purchase.

The partnership would combine the resources and expertise of these three organizations to reach more qualifying households than is possible with each organization acting separately. CfAL would apply its existing expertise in the ACP to training four (4) new staff members (two at CfAL and two at NHFPL). The City would act as a pass through for \$140,886.00 to CfAL to support the execution of the ACP Outreach and Sign-Up Event program.

A total of ninety-six (96) sign-up events will be held, forty-eight (48) at ECC residences and fortyeight (48) at NHFPL or other local non-profit locations. The new staff funded through the FCC Grant will assist residents with the sign-up process and lead the events and supervise volunteers. CfAL staff would also be on call in between sign-up events for any ECC residents requiring assistance signing up for the ACP and part time City staff will be on call for NHFPL patrons.

Marketing and outreach will include social media, email distribution lists, a direct mailing, posters and billboards, fact sheets and fliers, press releases and print advertisement. All marketing would be

multilingual, with a specific focus on Spanish, being the second most spoken language within the City. CfAL will create a dedicated Facebook page and an Instagram account dedicated to the ACP, local internet outages and other relevant connectivity information. A monthly newsletter will be created and disseminated on these outreach platforms.

**WHEREAS**, a lack of high speed internet access for many low-income households within the City of New Haven (the "City") has a negative impact on such households and serves to widen inequalities of opportunity between residents of the City; and

**WHEREAS**, such negative impact was most recently seen during the COVID-19 pandemic as children from low-income households struggled with access to remote learning; and

**WHEREAS**, the Infrastructure Investment and Jobs Act of 2021 appropriated \$14.2 billion for the Affordable Connectivity Program (the "ACP"), which provides qualifying low-income households with discounts on broadband service and connected devices, and expressly authorizes Federal Communications Commission (the "FCC") outreach in support of the ACP, including the provision of grants by the FCC to the FCC outreach partners; and

**WHEREAS**, approximately sixty (60%) percent of qualifying low-income households in the City are not signed up for the ACP and increasing participation in the ACP among qualifying households within the City is a cornerstone of the City's approach to enhancing equitable accessible to high-speed for all residents of the City; and

**WHEREAS**, the FCC has established the ACP Outreach Grant Program to provide eligible governmental and non-governmental entities with the funding and resources needed to increase awareness of and participation in the ACP among those eligible households most in need of affordable connectivity; and

**WHEREAS**, the City, acting through its Economic Development Administration and New Haven Free Public Library, proposes to partner with Concepts for Adaptive Learning ("CfAL") and Elm City Communities ("ECC") to create a two-year long program of outreach and sign-up events for the ACP, with a focus on low income, elderly, BIPOC and veteran communities; and

**WHEREAS**, the City would be the lead applicant for a \$277,617.00 grant application from the ACP Outreach Grant Program and would act as a pass through agency for partner organization CfAL; and

**WHEREAS**, assistance from the ACP Outreach Grant Program would fund the hiring and training of part time staff by CfAL and the City of New Haven through the NHFPL which part-time shall

support the outreach and sign-up event programs to be held largely at NHFPL and ECC venues, and would also fund outreach and marketing strategies coordinated by the City to publicize the availability of the ACP.

The City of New Haven, in partnership with Via Transportation Inc., is requesting authorization to apply for and accept funding from the Connecticut Department of Transportation (CTDOT) to operate micro-transit services as a pilot program.

The grant would fund implementation of on-demand micro-transit operations – in partnership with the New Haven Parking Authority, Greater New Haven Transit District and Via Transportation Inc.- as part of a pilot program. This pilot will complement existing CTTransit service while aligning with the mission and vision of the City of New Haven to provide safe, efficient, equitable and sustainable multi-modal transportation to improve quality of life and promotes economic vitality in the city. Micro-transit is defined as a transportation solution that is accessible by multi-passenger vehicles using a digital software application to offer on-demand service in response to individual or aggregate passenger demand.

The pilot program will provide on-demand transportation service to the public by:

- Making service more convenient, expanding coverage, improving customer experience and decreasing waiting times.
- Improving connections to fixed route services, providing first-mile, last-mile connections, connecting people to essential services such as health care, employment, education etc. and increasing access to jobs.

- Improving equity by expanding sustainable transportation options for disadvantaged populations, addressing safety concerns, addressing service needs of people with few mobility options.

Special focus will be placed on reaching residents in majority "priority neighborhoods" - consistent with the goals of the Board approved Safe Routes for All (SRFA) Active Transportation Plan- with majority low-income, Black, and/or Latino residents that have historically faced a number of challenges in relation to access to sustainable transportation options. Overall, emphasis will also be on ensuring fares remain reasonable and in-line with existing fares charged. The program will also take into consideration public outreach, customer experience, and marketing plans to promote and continuously improve the use of the new service.

We respectfully request your honorable Board's favorable action on the attached Resolution authorizing the Mayor to apply for and accept funding to implement micro-transit service operations as a pilot initiative through the Connecticut Department of Transportation Micro-transit Pilot Program.

WHEREAS, 29% of households within the City of New Haven (the "City") are zero-car households, meaning that nearly one (1) in every three (3) households relies upon transit, carpooling/rideshare, walking, or biking to move around the region; and

WHEREAS, 21% and 26% of Black and Latino households, respectively, do not own cars (as compared with 10% of white households) and for these demographic groups, unemployment and underemployment appear to correlate with rates of car ownership; and

WHEREAS, hospitalization rates for residents of the City attributable to chronic conditions such as diabetes, asthma, and heart disease are worsening at the highest rate in the region and the prevalence of asthma in New Haven's school district (14.7%) is the highest of all other school districts in the region, as well as the statewide prevalence rate of 14.3%; and

WHEREAS, institutions such as the Centers for Disease Control and Prevention maintain that strategies to promote exercise and activity, such as the provision of transit, walking and biking infrastructure, are essential to the health of American communities; and

WHEREAS, the current CTTransit New Haven system provides an extensive service as regards coverage of fixed routes, but does not provide point-to-point service as recommended by the Safe Routes for All Plan approved by the City's Board of Alders; and

WHEREAS, the City's Department of Transportation, Traffic and Parking, the City's Office of Climate and Sustainability, Greater New Haven Transit District ("GNHTD") and New Haven Parking Authority ("PARK New Haven") all recognize the need to improve equitable and sustainable mobility options that would help meet the City's broader climate goals, including ending community-wide greenhouse gas emissions by 2030, by enabling greater mobility without sole reliance on car ownership; and

WHEREAS, the Connecticut Department of Transportation ("CTDOT") has issued a request for proposals, entitled the CTDOT Micro-transit Pilot Program (the "Pilot Program") which is intended to spur the- development of on-demand micro-transit services, to be operated pursuant to the provisions of Public Act 22-40; and

WHEREAS, CTDOT requires municipalities which do not possess the vehicles, planning software, or staff necessary to operate the Pilot Program to partner with appropriate existing service providers (e.g., transit districts, taxi, livery, bus companies, transportation network companies) which are authorized by CTDOT to provide transportation services in the State of Connecticut (the "State"); and

WHEREAS, GNHTD is one of the 17 transit districts in the state that operates and provides a variety of transportation programs and services, and PARK New Haven operates and maintains numerous surface parking lots and garages in the center of the City and in surrounding neighborhoods; and

WHEREAS, Via Transportation Inc. ("Via") has assisted numerous municipalities and transit agencies across the United States of America in implementing and operating on-demand micro-transit services; and

WHEREAS, it is desirable and in the public interest that the City or the City together with GNHTD, PARK New Haven and Via, make an application (the "Application") to the CTDOT for up to \$3,500,000 and to partner with the GNHTD, PARK New Haven and Via in order to carry out the Pilot Program and to execute an Assistance Agreement for such purpose.

NOW, THEREFORE, be it RESOLVED by Board of Alders of the City:

- 1. that the filing of the Application in an amount up to \$3,500,000 is hereby approved and that Mayor Justin Elicker, Mayor of the City of New Haven is hereby authorized to execute and file the Application on behalf of the City (or, if appropriate, to authorize GNHTD or PARK New Haven to file the Application) with CTDOT to provide such additional information as may be required by CTDOT, to execute such other documents as may be required in the Application process, to execute an Assistance Agreement with CTDOT (or other appropriate agency of the State) for financial assistance (if such an agreement is offered) in the amount of \$3,500,000 or such lesser amount (if any) as may be offered by CTDOT (which Assistance Agreement may include an indemnification of CTDOT, the State and/or any other participating agencies of the State), to execute any amendments, rescissions, and revisions thereto, and to act as the authorized representative of the City with respect to all other matters pertaining to the Application; and
- 2. that it is affirmed that the City will partner with GNHTD, PARK New Haven and Via to carry out the Pilot Program and that the Mayor is hereby further authorized to enter into such agreements (together or separately with GNHTD, PARK New Haven and Via) as may be necessary or desirable to carry out the Pilot Program.

# ..BODY

WHEREAS, the South Central Connecticut Regional Water Authority, as agent for the South Central Regional Council of Governments and participating municipalities, has undertaken the permitting, construction and operation of a regional facility for the collection of household hazardous waste and conditionally exempt small quantity generator business waste at its headquarters at 90 Sargent Drive in New Haven; and

WHEREAS, the municipalities participating in the facility are able to have residents drop off their household hazardous wastes on Saturday mornings from 9 a.m. until noon, and conditionally exempt small quantity generators deliver business waste on Saturday mornings, by appointment from 7 a.m. to 8:30 a.m., from spring through fall for proper processing, transportation and disposal; and

WHEREAS, the facility is owned, managed and operated under the supervision of the South Central Connecticut Regional Water Authority for the benefit of the participating municipalities; and

# LET IT BE RESOLVED BY THE City of New Haven that:

The City of New Haven declares its commitment to continue participation in the regional household hazardous waste collection center for a minimum three year period (July 1, 2023 through June 30, 2026), and confirms its intent to contribute financially for the operation, processing, transportation and disposal of household hazardous waste on behalf of its residents.

LET IT ALSO BE RESOLVED that the City of New Haven authorizes its Mayor to enter into an agreement with the South Central Connecticut Regional Water Authority for the operation of the facility. Such agreement will permit the Authority to act as its agent to maintain the facility, to contract with a vendor for the transportation and disposal of the hazardous wastes, to receive financial support from grant sources, to enter into agreements with other municipalities and to operate the facility.

LET IT BE FURTHER RESOLVED THAT invoicing will be based on a two-part formula:

- 1. Annual operational costs are based on the number of 1 and 2- family housing units in New Haven, and
- 2. Annual transportation and waste disposal costs are prorated by residents' usage.

1. The Taxpayer shall execute an agreement with the City, approved by Corporation Counsel as to form and correctness, to pay the Taxes as specified in paragraph 4 hereinafter (the "Agreement"). The Tax Collector, acting pursuant to Chapter 205 of the statutes, shall cause to be recorded in the New Haven Land Records a certificate continuing the municipal tax lien, created by Section 12-172 of the statutes, with respect to the tax levied on the Property for the Grand Lists of October 1, 2021 and October 1, 2022.

4. The Taxes, plus any legal fees, shall be due and payable in full upon the earliest of the death of the Taxpayer, or when the Taxpayer no longer resides at the Property, or upon the sale or transfer of title to the Property, whether voluntarily or involuntarily or by operation of law. Interest shall accrue at the rate of six percent per annum (one-half percent per month) on the Tax Principal specified in paragraph 1 from the due date of each installment thereof. Any interest which may have accrued in excess of such rate prior to the execution and recording of the Agreement shall be abated (eliminated). Mary Lou Palumbo has submitted a petition to the Board of Aldermen for abatement (deferral of collection) of taxes due on her residence, Grand Lists of 2017 through 2022.

#### ORDER ABATING (DEFERRING COLLECTION OF) REAL PROPERTY TAXES DUE FROM MARY LOU PALUMBO ON HER RESIDENCE, GRAND LISTS OF 2017 THROUGH 2022.

ORDERED by the New Haven Board of Aldermen, acting pursuant to Section 12-124 of the Connecticut General Statutes, Revision of 1958 as amended, and Section 52 of the Charter of the City of New Haven, that the real property taxes laid for the Grand Lists of October 1, 2017, October 1, 2018, October 1, 2019, October 1, 2020, October 1, 2021, and October 1, 2022, (the "Taxes"), on the premises known as 40 Canner Street (the "Property"), which premises are the sole residence of Mary Lou Palumbo (the "Taxpayer"), be and hereby are abated (by which it is meant that collection of such Taxes shall be deferred) because said person is poor and unable to pay the same, provided that the following conditions shall be satisfied:

1. The Taxpayer shall execute an agreement with the City, approved by Corporation Counsel as to form and correctness, to pay the Taxes as specified in paragraph 4 hereinafter (the "Agreement"). The Taxes include the tax levied pursuant to law on the Property for the Grand Lists of October 1, 2017, October 1, 2018, October 1, 2019, October 1, 2020, October 1, 2021, and October 1, 2022 as that tax may be reduced by any tax credits or exemptions administered by the Assessor or Tax Collector pursuant to State law ("the Tax Principal"), plus the \$24.00 lien fee associated with the recording noted in paragraph 3 hereinafter.

2. The Agreement shall be in the form and manner required for the transfer of an interest in real property. It shall contain a legal description of the Property, shall be recorded in the New Haven Land Records, shall constitute a lien on said Property, and shall remain valid until paid.

3. The Tax Collector, acting pursuant to Chapter 205 of the statutes, shall cause to be recorded in the New Haven Land Records a certificate continuing the municipal tax lien, created by Section 12-172 of the statutes, with respect to the tax levied on the Property for the Grand Lists of October 1, 2017, October 1, 2018, October 1, 2019, October 1, 2020, October 1, 2021, and October 1, 2022.

4. The Taxes, plus any legal fees, shall be due and payable in full upon the earliest of the death of the Taxpayer, or when the Taxpayer no longer resides at the Property, or upon the sale or transfer of title to the Property, whether voluntarily or involuntarily or by operation of law. Interest shall accrue at the rate of six percent per annum (one-half percent per month) on the Tax Principal specified in paragraph 1 from the due date of each installment thereof. Any interest which may have accrued in excess of such rate prior to the execution and recording of the Agreement shall be abated (eliminated). The municipal tax lien and the lien created by the Agreement shall be released by the Tax Collector when the Taxes secured thereby have been paid.

5. The Agreement, properly executed by the Taxpayer, shall be returned by the Taxpayer to the Office of Legislative Services for final review by Corporation Counsel, execution by the Mayor and recording in the New Haven Land Records.

#### BACKGROUND

A Zoning Map Amendment is proposed for two parcels zoned RM-1 on Clinton Avenue and Perkins Street. The total approximate area of the property is 0.46+/- acres. The City of New Haven currently owns the property, along with the abutting parcel known as 69 Grand Avenue, which is improved with a two-story building that housed the Horace Strong School. Constructed in 1915, the Strong School Building was used as a public elementary school for nearly a century from 1916 to 2010. Both parcels comprising the property served the Strong School when it was still in use. The unnumbered parcel on Perkins Street (MBLU: 160 0761 02101) is improved with a vacant, one-story extension of the Strong School building. The 19 Clinton Avenue parcel is improved with a paved parking lot and a playscape. The three parcels have continuously operated as one campus, however, this campus is split-zoned. 69 Grand Avenue is zoned BA-1 while 19 Clinton Avenue and the Perkins Street parcel are zoned RM-1.

Since the Strong School closed in 2010 it has been vacant, and the city has worked to identify partners to redevelop the parcels. In May 2022 the city issued a Request for Proposals to redevelop the property and in October 2022 Pennrose's proposal was selected. Pennrose currently has a memorandum of understanding with the City related to its intended acquisition and development of the three parcels and is finalizing a Development and Land Disposition Agreement with the city.

#### CURRENT ZONING:

NHZO Article III, Section 13. *RM-1 Districts: Low-Middle Density*. These districts exist for the protection of areas that have been and are being developed predominantly for low-middle density dwellings of various types. Accordingly, the use of land and *buildings* within these areas is limited in general to dwellings at a density of about 12 dwelling units per acre, and to such non-residential uses as generally support and harmonize with a middle density area. The non-residential uses permitted in RM-1 Districts, subject to adequate conditions and safeguards, are hereby found and declared to be the only appropriate such uses for such areas. It is hereby found and declared, further, that these regulations are necessary for the protection of these areas and that their protection is essential to the maintenance of a balanced community of sound residential areas of diverse types.

#### PROPOSED ZONING:

NHZO Article V, Section 41- Description and purpose of business and industrial districts

Business A-1 Districts—Neighborhood Center Mixed Use. These districts serve as the commercial heart of their neighborhood, are of modest scale and pedestrian orientation, and seek to preserve and restore the historic architecture and urban pattern of the city. The emphasis is on neighborhood goods and services rather than comparison shopping, with a preference for smaller pedestrian-oriented, storefront retail, dinning, and other appropriate uses. They are intended as mixed-use districts with a mixture of ground floor retail, small offices, and upper story residential dwellings. Buildings are oriented to the street, parking requirements are reduced and parking maximums established to encourage walkability and community over automotive-related sprawl. New development is required by form requirements and design guidelines to conform to the neighborhood context,

to improve the retail character of the street as a neighborhood center, and to promote the health, safety and well being of residents by reducing sources of public nuisance and encouraging physical activity and community interaction and involvement.

#### **Comparison of Permitted Uses**

Uses permitted as-of-right in the RM-1 zone include residential use, home occupations and family daycares, some home-based office uses, religious institutions, schools and universities, cultural activities, agriculture, parks, public utilities, and healthcare uses. Uses permitted by Special Exception in the RM-1 Zone include fraternities and sororities, certain types of group homes, transition parking, temporary uses, recreation facilities, railroad and other rights-of-way, convenience stores, group daycare homes, and front yard parking.

The BA-1 zone also permits residential use, with a Special Permit required for residential use on the ground floor. Many additional commercial uses are permitted as-of-right in the BA-1 zone (for a full list, reference NHZO Article V, Section 42). A number of uses that may be less common for a Neighborhood Center Mixed Use District, or that have the potential to create a nuisance for the surrounding area, are permitted only by Special Exception or by Special Permit, including all proposed uses of greater than 5,000 net square feet, whether located in new or existing structures, in order to ensure that such relatively large proposals are compatible with and meet the general criteria and standards of the BA-1 Zone. There are also a series of Design Guidelines that apply to the BA-1 Zone.

In summary, while the BA-1 is more restrictive than other Business Zoning designations in the city, designed to protect neighborhood character and geared toward small business districts of a neighborhood scale, it allows many additional commercial uses as-of-right. The BA-1 Zone also has bulk requirements designed for a business corridor of active storefronts with minimal front yards.

### **PUBLIC HEARING**

A public hearing was held on April 19, 2023. A transcript of the hearing, meeting #1630, is available from the City Plan Department. Eighteen items of public testimony were received in advance of the meeting, all in support of the item.

Topics raised in public testimony included:

- Support for the petition
- Appreciation for the developer's community outreach
- Need for the redevelopment of the vacant Strong School
- Alignment with the goal stated in the Comprehensive Plan to revitalize Grand Avenue

- Support for bringing the three parcels of the Strong School Campus into the same zoning district
- Proximity of the proposed business district to public open space
- Facilitation of historic preservation
- Proximity to public transit (bus route)

# CONSISTENCY WITH THE POLICIES AND STANDARDS OF THE CONNECTICUT COASTAL MANAGEMENT ACT

The subject parcels are located in the Coastal Management Area. Zoning text and map amendments that impact parcels in the Coastal Management Area are mandatory referrals to the Connecticut Department of Energy and Environmental Protection (DEEP). In a letter dated April 5, 2023, CT DEEP, Land and Water Resources Division staff stated that they find the proposed zoning map amendment to be consistent with the Connecticut Coastal Management Act.

#### PLANNING CONSIDERATIONS

The City Plan Department has been working closely with Livable City Initiative, the Economic Development Administration, and community members in Fair Haven on the redevelopment of the Strong School campus for many years. Planning Staff worked closely with the applicant to determine that a Zoning Map Amendment was the best approach to achieve planning goals for this key corner of Grand Avenue. As noted in the background section of this report, the three parcels have long been used as one 'campus' and bringing them all into the BA-1 Zone, which was designed to support neighborhood-scale, pedestrian-oriented development, is a logical step in supporting redevelopment.

The proposed Zoning Map Amendment supports many goals of the City's Comprehensive Plan, including:

#### New Haven Vision, 2025, p. IV-12:

"Support the provision of affordable, workforce (middle income) housing within the City. To that end, explore the feasibility of incentivizing developers who provide workforce housing through reduced parking, where appropriate, and other incentives."

#### New Haven Vision, 2025, p. xx-iii:

"Build mixed-use developments along all of the city's commercial corridors, as indicated within the future land use map, through necessary zoning amendments."

#### New Haven Vision, 2025, p. IV-13:

"Identify historic structures that can be successfully used to meet the City's affordable housing goals. Low-income housing and historic rehabilitation tax credits can be combined when historic structures are rehabilitated for affordable housing."

#### New Haven Vision, 2025, p. IV-26:

"Continue to focus on revitalization efforts on Grand Avenue to promote vibrancy and strengthen local economy within this commercial corridor."

#### SECTIONS(S) 181 and 182 OF THE CHARTER OF THE CITY OF NEW HAVEN

The City Plan Commission finds that, based on submitted information the proposed map amendment comply with Sections 181 and 182 of the Charter of the City of New Haven in that it is (i) uniform for each class of buildings or structures, (ii) made in accordance with the comprehensive plan, (iii) designed to lessen congestion in the streets, secure safety from fire, panic and other dangers, promote health and the general welfare, provide adequate light and air, prevent the overcrowding of land, avoid undue concentration of population, facilitate the adequate provisions for transportation, water, sewerage, parks and other public requirements, and (iv) made with reasonable consideration as to the character of the proposed BA-1 District and its peculiar suitability for particular

uses and with a view to conserving the value of buildings and encouraging the most appropriate use of land throughout the City.

#### SECTION 64(d)(2)c OF THE NEW HAVEN ZONING ORDINANCE

Section 64(d)(2) requires that the City Plan Commission take into consideration in evaluating any amendment to the Zoning Map:

a. Errors in the existing ordinance, changes that have taken place in the city and in patterns of construction and land use, the supply of land and its peculiar suitability for various purposes, the effect of a map change on the surrounding area, the purposes of zoning and the comprehensive plan of the City of New Haven;

The proposed zoning map amendment responds to changes that have taken place in Fair Haven, along the Grand Avenue corridor, and on the Strong School 'campus,' and changes in patterns of construction and land use in the city, including the great need for affordable housing and denser residential development. The Planning Considerations section of this report discusses the strong alignment with the City's Comprehensive Plan.

*b. Whether some other method or procedure under the zoning ordinance is more appropriate; and* The applicant has worked closely with Planning Staff to determine that a zoning map amendment is appropriate for this location.

c. In the case of a map change, the size of the area involved. As a general policy, the City Plan Commission shall not consider favorably any petition which would result in a total contiguous area (separated only by streets, and excluding the area of streets) of less than two acres in the case of a residence district, less than one acre in the case of a Business District, or less than four acres in the case of an Industrial District.

The subject parcels are adjacent to the existing BA-1 zone along Grand Avenue and will result in a 0.46 acre increase to the BA-1 zoning district which is over 40 acres.

#### FINDINGS AND ADVICE

Based on the above it is the recommendation of the Commission that the proposed map amendment is in full compliance with the standards and requirements of Section(s) 181 and 182 of the Charter of the City of New Haven and Section 62(d)(2) of the New Haven Zoning Ordinance and should be approved.

### BACKGROUND

The City of New Haven is requesting authorization to apply for and accept funding from the Environmental Protection Agency's Environmental Justice Government-to-Government Program.

The grant would fund an initiative by the City of New Haven and one or more community-based organizations to enroll energy-burdened New Haven residents in a new program aimed at the electrification of aging heating and cooking systems. These systems are often costly, inefficient, and can exacerbate health conditions related to indoor air quality, such as asthma. They are also significant contributors to the air pollution that causes climate change. Replacing these systems with new high efficiency electric appliances such as heat pumps and induction stoves can reduce energy bills, improve public health, and reduce climate pollution.

The Office of Climate and Sustainability (OCS) anticipates working with one or more communitybased organizations that have experience connecting residents with utility assistance in order to identify low- and moderate-income residents with aging heating and cooking systems. Special focus will be placed on reaching residents in DEEP-designated environmental justice census tracts in West Rock/West Hills, Newhallville, Dixwell, the Hill, Fair Haven, and the Annex neighborhoods. OCS plans to work with these organizations to inform and engage residents about the benefits of new high efficiency electric appliances and enroll them in the new electrification program. The organization or organizations will be selected through the City's competitive procurement process.

Once enrolled, OCS plans to work with another community-based organization or electrification service provider to design, identify funding and financing for, and implement electrification improvements. This organization will scope out energy efficiency and electrification improvements and work with energy-burdened residents to maximize the benefits available to them, with the objective of shifting residents to a fully-electrified home. Grant funds will be reserved to assist residents with some of the cost of electrification improvements and the removal of remediation barriers to energy efficiency, such as mold and asbestos.

#### PLANNING CONSIDERATIONS

This grant proposal is aligned with the City comprehensive plan from the standpoint of:

- Improve air quality
- Commitment to sustainable environmental policy and a systematic approach to energy efficiency and development of renewable energy resources of further improve air quality and ensure a high quality environment.
- Clean and protect environmentally sensitive areas;

- Commitment to quality of life issues, balancing economic development, environmental protection and cultural enrichment.
- Encourage environmental justice

#### ADVICE

Authorization of this grant application aligns with the City's Comprehensive Plan and the State of Connecticut's goals.

#### BACKGROUND

The Livable City Initiative ("LCI") is submitting for communication an Order requesting a lease (the "Lease Agreement") between Gather New Haven, Inc. (the "Gather New Haven") and the City of New Haven (the "City"). Gather New Haven operates community gardens to serve the residents of our City. The Community gardens contribute to the vitality of our neighborhood by engaging residents and strengthening our community, improving our health, and protecting the environment. The Land Trust and New Haven Farms have previously leased, and, or licensed land from the City of New Haven for terms of five (5) years for a rent of \$1.00 per annum and the current lease will expire on June 30, 2023. The City proposes the execution and delivery of a five (5) year Ground Lease between the Gather New Haven, Inc. and the City of New Haven with respect to the following properties: 11-13 Ann Street, 280 Goffe Street, 49 Bassett Street, 117 Bristol Street, 211 Rosette Street, 145 Davenport Avenue, 216-220 English Street, 613-619 Ferry Street, 8-10 Arthur Street, 12 Arthur Street, 221- 225 Shelton Avenue, 255 Shelton Avenue, 257 Shelton Ave, 138 Ivy St, 66 Liberty Street, 24-26 Adeline Street, 28 Adeline Street, 36 Redfield Street, 42 Shelter Street, 96 Shepard Street, 358 Blatchley Avenue, 226 - 228 Starr Street, 242 - 248 Starr Street, 47 Stevens Street, 60-62 Truman Street, 64-66 Truman Street, 170 Ward Street, 56 William Street

#### PLANNING CONSIDERATIONS

On January 1, 2020, New Haven Farms and New Haven Land Trust merged into a single organization, now known as Gather New Haven. Since 2012, New Haven Farms and New Haven Land Trust, now Gather New Haven, have operated approximately 5 farms and more than 45 community gardens on land owned by the City of New Haven. These sites are used to serve the residents of New Haven through farming and offering educational opportunities regarding organic sustainable practices surrounding farming, health, and nutrition. The farms enhance the surrounding neighborhoods by providing recreational and educational opportunities for community members and increasing local rain water absorption through the various permeable surfaces that exist throughout the sites. It also fulfills the Comprehensive Plan goal of enabling urban farm siting locations and supporting commercial food production in all zones of the city, including industrial zones.

# BACKGROUND

Livable City Initiative has submitted a list of non-profit organizations applying for eligibility to receive donations under the State of Connecticut 2023 Neighborhood Assistance Act. In accordance with Chapter 228a of the General Statutes of Connecticut, this list must be presented to the Board prior to submission to the State of Connecticut's Commissioner of Revenue Services. The deadline to submit the proposals to the Department of Revenue Services is July 1, 2023.

The Neighborhood Assistance Act is a program of the State of Connecticut Department of Revenue Services. The City of New Haven acts as a liaison between the non-profit organizations and the State of Connecticut. The program is a tax credit program for corporations to donate funding to the community programs and receive a tax credit from the State of Connecticut for said donations.

### PLANNING CONSIDERATIONS

Accepting and approving the list of proposals complies with the City's Comprehensive Plan:

**New Haven Vision 2025, Section VI-21, Economic Development:** "Partner with local private institutions, major employers, arts organizations, and other non-profit organizations to increase programming, marketing, and funding opportunities for arts and cultural events in New Haven and further stabilize New Haven's positioning as a regional, as well as, world-class destination for arts and entertainment."

All proposals have been inspected by Livable City Initiative to ensure that every question is specifically answered to provide the complete disclosure of information appropriate to meet the expectations of the Board of Alders including, but not limited to: providing the tax-exempt number, a description of the organization if it is not a tax exempt or a municipal agency, and the percentage of the people directly served by the population who are under 150% of the poverty level.

#### BACKGROUND

#### The Property

The project site encompasses a lot area of approximately 107,575 SF (2.47 acres) and consists of several multi-story residential buildings, surface parking lots, and concrete sidewalks. The site is bounded by Portsea Street in the north, Dewitt Street in the west, and residential properties in the south and the east.

#### **Project Description**

Hill Central was constructed in 1980 as an affordable housing cooperative. It operated in the program up until June of 2017 when the property was sold by its members to Hill Central, LLC. The property has remained affordable and is covered by a Section 8 HAP contract. As part of the sale, the buyer, Hill Central, LLC expressed a desire to redevelop the property and this application is a result of that intention.

# A. Statement of the nature of the proposed project: low and moderate income housing, market rate residential, commercial, industrial, etc., and whether the Property is to be owned or leased.

There are presently 72 three and four bedroom units at Hill Central. All are covered by a HAP contract with HUD. The physical design of the property is such that it is split into two halves by K-8 New Haven public schools Hill Central School, and Roberto Clemente School To facilitate redevelopment, we have elected to present what we call Parcel D for this tax abatement application, also known as Hill Central Phase I. Hill Central Phase I presently houses 32 three and four bedroom units and has significant underutilization of the property. The plan contemplates the demolition of the existing 32 units replacing them with 64 units. The replacements will have the following mix:

- 18 three bedrooms units,
- 14 four bedroom units (both match existing conditions),
- 24 one bedroom units,
- 8 two bedroom units.

Within the new mix, 80% will affordable, and 20% will be market rate. All affordable units (80% or 51 units) will be covered by a HAP contract. Further broken down, the 80% affordable units will have 30%,

50%, and 60% AMI set asides, and 13 of the units will be supportive housing administered by Columbus House and covered by Housing Choice (Section 8) project-based vouchers from Elm City Communities.

#### The Financing Plan

Funding for the project comes from multiple sources:

- 1. 9% Low Income Housing Tax Credits
- 2. CT DOH Flex Funds
- 3. CT DOH HOME Funds
- 4. CHFA CMF Funds
- 5. CHFA Permanent Debt
- 6. UI Energy Rebates
- 7. Existing Reserve Funds
- 8. TD Bank Construction Loan

### Tax Abatement

The proposed duration of the rental tax exemption is 17 years at \$1,000 per unit, increasing each year by 3%.

# PLANNING CONSIDERATIONS

This Commission previously approved the Site Plan (Hill Central Redevelopment Phase One construction of 64 residential dwelling units) for the HCl, LLC development (CPC Report #1547-04). The new development meets many of the city's overall goals from both an affordable housing and neighborhood development perspective. While the tax agreement will be further reviewed by the appropriate city entities, the Commission lends its support to the project as highly consistent with the Comprehensive Plan of Development.

# BACKGROUND

This request comes from the Board of Alders regarding an ordinance to designate the corner of Edward B. Grant Way to Charles "Charlie" Arcangelo Corner in perpetuity, for his support, contributions, and service to the New Haven community.

Charles Arcangelo was born in New Haven in 1946 and proudly served his country in the Vietnam War earning multiple medals of distinction. After completing his service, he returned home to begin his career in the family owned and operated auto recycling business, which began in 1947. As an automotive scrap metal recycler and the owner of Chuck & Eddie's Used Auto Parts his business flourished and grew largely due to his strong business sense and future vision of scrap operations. The fourth-generation family owned, and operated business is now comprised of six integral locations in Connecticut, Massachusetts, and includes used auto sales, and offsite scrap operations.

While his business grew Charles raised four successful children and enjoyed being a grandfather to his seven grandchildren. Employing over 200 individuals he was a beloved leader of his company leaving a lasting impression on all who worked with him.

One of his best-known traits was his generosity. Each holiday he donated turkeys to the community, toys for children at Christmas, and clothing for those in need. Very active in the community he also donated to various local and regional organizations as well. Supplying cars to local fire and rescue departments allowed them to practice first responder techniques and to train new recruits. One of several programs he donated to was the Police Explorers Program, a youth-oriented program that allows young men and women to determine if they would like to pursue a career in law enforcement as adults by offering them actual experience and training. This program also provides human resource opportunities to those individuals not pursuing a career in law enforcement. Cash, food, delivering meals to needy families, support, his family continues these generous gestures to honor his legacy donating to families that need help. Charles Arcangelo graciously served individuals in the community by making a difference in their lives.

According to Section 18-2(a)(3) of Title III, Chapter 18, Article I of the City's Code requires, **"Each submission shall contain:** 

- (i) Plan of the site of the proposed location indicating all structures and street features as well as the proposed signage drawn to scale for review by the city.
- (ii) Proposed wording of the signage.

(iii) A petition of at least two hundred fifty (250) city resident signatures in favor of the proposed naming, of which at least two-thirds (2/3 (one hundred sixty-six ((166)) shall be residents of the neighborhood of the proposed sign location."

# PLANNING CONSIDERATIONS

This proposal in accordance with Title I, Article XIII, Section 2(A) of the New Haven Code of Ordinances states, "Every Ordinance or Resolution of the Board of Alders relating to the location and use of any street, bridge, boulevard, esplanade, square, park, playground, playfield, aviation field, parking space, public building, the facilities or terminals of any public utility, or the establishment or change in the boundaries of or regulations concerning zoning, shall be at once referred to the City Planning Commission and final action shall not be taken on any such Ordinance or Resolution until the commission shall have reported thereon, provided that the Board of Alders may establish by ordinance a period of not less than sixty (60) Days within which the commission shall file its report with the City Clerk and if no report is filed within such period the approval of the commission shall be presumed." Accordingly, the Board of Alders seeks guidance regarding the proposed amendment.

The Board of Alder seeks guidance as to:

- Whether the proposal is aligned with the City's Comprehensive Plan.
- Whether the proposal is "complete" and meets the criteria set forth in Section 18-2(a)(3) of Title III, Chapter 18, Article I of the City Code.

# PLANNING CONSIDERATIONS

While the proposal is aligned with the City's Comprehensive Plan because it, 'fosters a greater "sense of place" and neighborhood pride' by honoring an active member of the New Haven community, the Commission notes that the proposed location for the sign is at the corner of a street named to honor another prominent New Haven leader: Edward B. Grant. The Commission notes that the addition of a sign to honor an additional individual would diminish the honoring of Edward B. Grant and urges the applicant to consider an alternative location. The Commission also notes that the signatures on the petition do not appear to meet the requirements of Section 18-2(a)(3) and two of the other requirements of the ordinance have not been met (a plan of the site of the proposed location indicating all structures and street features as well as the proposed signage drawn to scale for review by the city, and proposed wording of the signage were not provided).

# ADVICE

The City Plan Commission recommends that the Board of Alders does not approve the item because 1) the application does not meet the requirements of the ordinance and 2) because a different location should be identified so that the current name of the street (Edward B. Grant Way) which already honors a New Haven leader, is not overshadowed.

### BACKGROUND

As per Charter, Mayor Elicker submitted a proposed FY23 budget for general, capital and special funds to the Board of Alders for their review and approval. The Board in turn referred the proposal to the City Plan Commission for review and comment. The proposed \$662.7 million budget represents an increase of 4.66%, or \$29.5 million, over last year's budget. The Mayor is recommending a reduction in the mill rate, from last year's rate of 39.75 to 37.20, or a reduction of 6.42%, which would lower property taxes than they otherwise would have been, absent the increase in property values.

### PLANNING CONSIDERATIONS

As a general point, in its review of the annual budget, the Commission has historically made note of issues relating to the Comprehensive Plan and the operation of the City Plan Department and does not take a line-by-line review of the budget overall. The FY23-24 budget continues to address the impacts of the "once in a generation" crisis which included significant financial constraints and the COVID-19 public health crisis. As to specific points in the budget, the Commission is pleased to see redesignated funding to support Parks, Recreation and Youth which will uphold the city's long-term commitment to public greenspaces and support young people through engaged programming in our most historically underserved neighborhoods, as well as a renewed commitment to addressing climate change through the Office of Climate and Sustainability. We note that while the City Plan Department's request of \$866,016 includes the addition of a Planner III position which will substantially improve our capacity to serve the public and improve regulatory functions. Given that nearly all of our staff are in Planner II positions, this position also creates incentives for our talented staff to stay with City by creating a ladder for professional growth and development.

#### BACKGROUND

The Board of Alders has referred to the City Plan Commission, for its advice, an Order requesting approval of the Development and Land Disposition Agreement ("DLDA") for the former Strong School location at 69 Grand Avenue in Fair Haven.

The Strong School has not operated at this location since 2010 and has remained vacant (except for periodic use as storage by New Haven Public Schools) since that time. During this time, multiple attempts by the City of New Haven to solicit qualified developers of the site with proposals that provide the highest and best use as well as significant community benefit have been unsuccessful.

In Summer 2022, a two-year community engagement process on the future of the Strong School involving hundreds of Fair Haven residents and including a joint City and community-led feasibility study of the building culminated in the release of a Request for Proposals (RFP) that balanced community aspirations and concerns about artistic and cultural inclusion as well as affordable housing with historic preservation of the building and financial viability of any future project. A final public meeting attended by over 75 residents was held in September 2022 to hear the proposals directly from the RFP respondents.

Following the recommendation of a Selection Committee composed of the affected Alder, community members and representatives from the City's planning, economic development and housing divisions, Pennrose was selected as the preferred developer for the Strong School. Their proposal includes an adaptive renovation of the historic school building that will provide no less than 50 affordable housing units as well as community arts and culture space including live/work spaces for local artists. An LGBTQ+-friendly environment is another key aspect of the project vision.

The estimated total cost of the project is \$25 million with a projected completion date of 2025. The developer is proposing that all ~50 residential units -- which includes a mix of studio, one bedroom, and two-bedroom apartments -- will be affordable units for households between 30% to 80% of the area median income ("AMI"). The vast majority of units (over 40) are projected to be deeply affordable housing for households between 30% and 60% of the AMI.

Furthermore, Pennrose is ranked among the top 25 affordable housing developers nationally and has unique expertise in historic school restoration. Pennrose recently redeveloped the historic Mary D. Stone School in Auburn, MA into mixed-income senior housing and was awarded the 2022 Affordable Housing Finance Magazine Reader's Choice Award for the conversion. Pennrose is also completing redevelopment of the historic William Barton Rogers Middle School in Boston, MA, which will be New England's first LGBTQ-

friendly senior affordable housing development. They have completed similar projects in many Connecticut cities and towns including Hartford, Torrington, and Meriden.

In addition to Pennrose, the development team includes: The Cloud Company, a 100% minority-owned, CT-based real-estate development firm; WRT Planning and Design; and historic consultant PAL Inc. Following construction, the property will be managed by the Pennrose Management Company which will help ensure the buildings are kept in a state of good repair.

The City and Pennrose anticipate a three-year planning and construction timeline while continuing to work closely with community partners as the project moves forward. Pennrose will also have to go through the City's regular land use approval process which will allow multiple opportunities for further input before the project becomes a reality. Quarterly status updates will also be provided to the community by the City and the developer via the regular meetings of the Fair Haven Community Management Team

The Strong School is a truly special building and site and the City is excited to begin this redevelopment and renovation project with Pennrose to deliver more affordable housing to the Fair Haven community. The project's added focus on creating community arts spaces will also help highlight the artistic contributions of residents and the cultural vibrancy that truly defines Fair Haven and the City as a whole. Furthermore, engaging Fair Haven residents in a robust public process helps ensure this is a high-quality project responsive to the community's values, needs and concerns.

#### PLANNING CONSIDERATIONS

The City Plan Department has been working closely with Livable City Initiative, the Economic Development Administration, and community members in Fair Haven on the redevelopment of the Strong School campus for many years. The DLDA that will allow the redevelopment of the former Strong School Campus as a mixed-use project adding at least 50 new affordable housing units, and new commercial space, complies with the City's Comprehensive Plan that calls to:

#### New Haven Vision, 2025, Sec. IV-12:

"Support the provision of affordable, workforce (middle income) housing within the City. To that end, explore the feasibility of incentivizing developers who provide workforce housing through reduced parking, where appropriate, and other incentives."

#### New Haven Vision, 2025, Sec. xx-iii:

"Build mixed-use developments along all of the city's commercial corridors, as indicated within the future land use map, through necessary zoning amendments."

#### New Haven Vision, 2025, Sec. IV-13:

"Identify historic structures that can be successfully used to meet the City's affordable housing goals. Low-income housing and historic rehabilitation tax credits can be combined when historic structures are rehabilitated for affordable housing."

This project is a win-win for neighborhood and the New Haven community at large and represents the fruition of a community driven process to make best use of a deteriorating school building. The innovative adaptive reuse of the building will retain a valuable architectural resource that will serve to enhance community and social capital in the neighborhood. The addition of affordable housing units, particularly focused on a traditionally underserved LGBTQ population, addresses significant needs for more housing in this neighborhood. Staff also note that this project will further the City's "Resolution

Endorsing the Declaration of a Climate Emergency to Restore a Safe Climate, adopted on September 3, 2019 in that Section 4.5 of the DLDA outlines the Commitment of Sustainability including: commitment to carbon reduction measures, installation of all electric heating, ventilation and air conditioning systems, hot water systems, and appliances in all of the residential units, design and build a photovoltaic array with minimum module efficiency of not less than twenty percent (20%) to cover all roof area not utilized for mechanicals, and providing Level 2 electric vehicle charging stations in at least twenty (20%) percent of the parking spaces.

### BACKGROUND

ART CT 770 LAND, LLC acquired the former Von Roll site at 128-166 Chapel Street in 2019 and moved its affiliated business, Art to Frames there from Brooklyn, NY in 2020. ART CT is proposing to acquire the City's adjacent 25,000 square foot lot at 112 Chapel Street, aka Redevelopment Parcel A in the City's River Street Municipal Development Project Plan area, to develop as a parking lot which will support its proposed 10,000 square foot expansion of its plant.

Environmental investigations conducted by both Facility Support Services and, more recently, Tighe & Bond, have indicated that remediation of the site will be needed prior to construction of the parking lot and building Project. Remediation will include removal of soil and debris impacted with PCBs, lead and oil due to the historic operations on the site, which will be backfilled with clean fill material and paved to cap contaminant levels acceptable under the Connecticut Remediation Standard Regulations.

The City has the opportunity to obtain up to \$750,000.00 in funding from the Connecticut Department of Economic and Community Development's Municipal Brownfields Grant Program to conduct said remediation project.

Art to Frames plans to hire an additional 15-20 people to supplement its current staff of 80 people once the Project is completed.

#### BACKGROUND

Conncorp, LLC (the "Developer") is planning to remediate and redevelop the 7.6-Dixwell Plaza site which consists of 11 parcels, primarily located on Dixwell Avenue between Webster and Charles Streets (the "Site"). The Site will be developed in two phases, with Phase I will including 174 housing units (20% of which will be affordable) a daycare center, grocery store, food hall, child and family guidance center, job training facilities and a business incubation laboratory (the "Project").

Past environmental assessments of the Site have concluded that hazardous materials identified in soil, primarily due to the presence of widespread polluted fill material on the Site, should be removed prior to commencement of construction (the "Remediation"). The environmental consultant for the Project, Verdantas, LLC, is recommending that impacted soil be excavated at three localized areas, including adjacent to a former dry-cleaning operation, as well as from a broader area containing fill materials contaminated primarily with PAHs and ETPH and lead. Building demolition and abatement will precede soil cleanup. The material will be disposed of off-site unless there is room to retain some of it on-site. The remediated Site will be capped with buildings, pavement and landscaping.

The City on December 12, 2022, received approval from the Connecticut Department of Economic and Community Development (the "State") of its \$2,000,000 Round 16 Brownfield Municipal Cleanup Grant (the "Cleanup Grant") Application on behalf of the Project to begin demolition and subsurface remediation at the Site. Although this initial funding is an important step in realizing the Project, subsequent demolition and abatement work will be needed to complete and move beyond Phase I of the Project.

The City has the opportunity to obtain up to \$4,000,000 in funding from of Round 17 of the State's Cleanup Grant to conduct the Remediation.

#### **REPORT: 1630-18**

#### BACKGROUND

The Engineering Department oversees the facility management of the New Haven Police Services Buildings portfolio, consisting of One Union Avenue, 9 Substations, 710 Sherman Parkway, 170-200 Wintergreen Avenue, and associated infrastructure. For many years the Police Services complex has been maintained through a private management contract structure, which has assisted the City in maintaining the buildings in good condition at a competitive rate.

As the budgetary authority of the City, the Board of Alders provides a general fund budget line item each year to the Engineering Department to cover the operation of the Police Department facilities among other things. The management contract is paid out of this line, and consists of two parts: first, a set management fee is paid to the contractor to manage the buildings and oversee all subcontracts that are part of the maintenance of the building (\$60,000 FY22-23); second, there is a budget for reimbursable expenses undertaken by the management contractor on behalf of the City (\$723,410 FY22-23). Only the management fee is set under the terms of the contract. The budget for reimbursable expenses is set each year depending on the allocation provided by the Board of Alders for that fiscal year. Please note that reimbursable expenses undertaken by the City directly per the contract (e.g. utilization of the Small Contractor Development Program).

To date, the contracting structure has been for 1-year contracts, each procured through an RFP that included up to four possible renewals at the same terms and conditions. This results in a new round of procurement approximately every 5 years. As the City is nearing the end of its available renewal terms in its existing contract, the Engineering Department will be conducting another RFP this spring for facility management services.

However, in an effort to secure better pricing, reduce contracting overhead, and increase transparency, the Engineering Department would like to solicit for a single 5-year agreement rather than a 1-year agreement with four renewal terms. The City would still be able to end the contract each year at no cost thanks to a termination clause, and the Board of Alders would still be able to set the yearly general fund allocation for the maintenance of the buildings. One of the primary benefits is that a 5-year agreement would allow for adjustments for inflation of the management fee over the life of the contract, whereas the current structure requires the same management fee over all the renewal periods. This can result in inflated management fees in the early years.

Also, a 5-year contract may be more appealing to respondents as it has a longer duration despite any termination clauses and can also improve pricing. Continuity in management of the buildings is desirable

for the City, as more frequent turnover can result in less efficient building management. It is certainly our belief that a single 5-year agreement both more accurately reflects the course of business and can result in more competitive pricing without sacrificing any of the options and control that the City in general and the Board of Alders in particular can exert.

#### PLANNING CONSIDERATIONS

The proposed 5-year contract will improve efficiency of use of city resources to maintain public facilities (in this case, the NHPD complex portfolio).

#### ADVICE

Authorization of a multi-year agreement with the successful RFP respondent is in accordance with the City's Comprehensive Plan and should be approved.

#### BACKGROUND

The State of Connecticut has offered funding to the Historic Wooster Square Association from the State's American Rescue Plan Act (ARPA) allocation. The Historic Wooster Square Association has approached the City of New Haven to undertake improvements to their district as a subrecipient of the grant, including traffic calming, lighting, and park improvements. The proposed budget for the City as a subrecipient is \$452,400.

The City proposes accepting this funding from the State of Connecticut through the Historic Wooster Square Association, and working with the Wooster Sq community to implement the project. The proposed improvements will be beneficial to the health and well-being of the general public, and will occur in the public right-of-way and park areas.

#### PLANNING CONSIDERATIONS

This grant proposal is aligned with the City comprehensive plan from the standpoint of:

- Preserving the historic character of the city
- Continue to enhance the image of all city parks to make them accessible, inviting, exciting, and well maintained
- Encourage multi-modal transportation planning within the city by promoting transportation infrastructure and traffic calming improvements and effective transportation demand managementstrategies.

It is important to note that any changes viewable from a public way within the Wooster Square Local Historic District will require a Certificate of Appropriateness from the Historic District Commission.
