27 animals were taken into the shelter (20 dogs, 5 cats, 2 roosters).

9 animals were redeemed by their owners.

8 animals were adopted out as pets (includes 4 that were transferred as pets).

2 dogs and 1 cat arrived at the shelter deceased (Public Works drop offs).

4 dogs and 1 cat Euthanized (3 sick dogs- at Central, 1 dog at shelter due to temperament by Dr. Sabo, 1 cat hit by car- at Central).

35 animal complaints were investigated.

0 dog bite reports from patrol were followed up on by staff.

We ended the month with 33 animals (29 dogs and 4 cats).
