VI. Old Business:

A. Pilot program

O'connell: General questions: why is the amount \$7,500 for board of ed and not half of the Mayor's grant amount?

Administrator Heimer: this amount is half of the original grant amount set in 2007. If you want to change that, this is the time.

O'Connell: I want to see that residents of the ward only required to donate. For the upcoming Republican primary we are spending about \$100,000.00 as a city to help 200 Republicans come out and vote. This is a vast expansion and a significant expense.

Ficca motioned to change the amount for the Board of education grant to half of the mayor's grant for the given year. 3-2-0.

Option for Alders to use 3 ways to fundraise. Grant will be \$1500 for the pilot program.
