

TRAFFIC AUTHORITY MINUTES
OCTOBER, 2021

The Traffic Authority of the City of New Haven, duly warned, met in Chambers, One Union Avenue, New Haven, Connecticut on, October 12th 2021.

The meeting was called to order at 6:04 PM, Commissioner Ribeiro presiding.

The minutes of the August, 17th, 2021 meeting were approved.

The following items were presented:

Item 1. Request of Kimberly Edwards, Alder, Ward 19, Traffic and Parking for establishing TWO HOUR PARKING 8AM-7PM, Monday-FRIDAY, RESIDENTIAL PARKING PERMIT HOLDERS EXEMPT regulation on the north side of Huntington Street from Whitney Avenue to 23 Huntington Street. Approval recommended.

Karla Lindquist presented the technical report. Commissioner Walker moved to approve the item. Commissioner Miranda seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 2. Request of Giovanni Zinn, City Engineer, for rescinding TWO HOUR PARKING regulation and for establishing POLICE ONLY parking regulation of the east side of South Orange Street from South Frontage Road to Columbus Avenue. Approval recommended.

Karla Lindquist presented the technical report. Commissioner Meares moved to approve the item. Commissioner Walker seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 3. Request Giovanni Zinn, City Engineer, for rescinding NO PARKING regulation and for establishing POLICE ONLY parking regulation of the south side of West Water Street from Meadow Street to South Orange Street. Approval recommended.

Karla Lindquist presented the technical report. Commissioner Walker moved to approve the item. Commissioner Miranda seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 4. Request Giovanni Zinn, City Engineer, for rescinding 12 HOUR PARKING regulation and for establishing POLICE ONLY parking regulation of the west side of State Street North from Water Street to Fair Street. Approval recommended.

Karla Lindquist presented the technical report. Commissioner Walker moved to approve the item. Commissioner Miranda seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 5. Request Giovanni Zinn, City Engineer, for rescinding NO PARKING regulation and for establishing unregulated parking regulation of the inset in the north side of Foote Street between John Daniels Place and Dixwell Avenue. Approval recommended.

Karla Lindquist presented the technical report. Commissioner Walker moved to approve the item. Commissioner Miranda seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 6. Request of the Department of Transportation, Traffic and Parking for parking controls in areas less than one block in length as indicated below be approved.

A. Establish RESERVED FOR HANDICAPPED parking spaces.

- 1. In front of 468 Edgewood Avenue..... 1 space
- 2. In front of 134 Exchange Street..... 1 space
- 3. In front of 31 Tilton Street..... 1 space


B. Rescind RESERVED FOR HANDICAPPED parking spaces.

- 1. In front of 374 Ellsworth Avenue..... 1 space

Approval of A. and B. is recommended.
