REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE NEW HAVEN SOLID WASTE AND RECYCLING AUTHORITY

A regular meeting of the New Haven Solid Waste and Recycling Authority (the "Authority") was held on June 10, 2021 at 5:30 p.m. online via Zoom Video Conference call.

Gerald Antunes began the meeting at 5:48 p.m. with approval of the May 13, 2021 minutes. Richard Miller made a motion to approve the minutes, seconded by Margaret Targove. There was no further discussion.

The trip and fall claim is being investigated. Mr. Barbour is in touch with the Authority's attorneys and will update the Board as information becomes available.

Mr. Barbour stated that he is in the process of entering into an agreement to allow entry through the Authority's leased Chapman Property to Outdoor Communications a subsidiary of CBS, so that they can access their billboard property to install a new billboard.

Mr. Barbour indicated that the Authority is looking to host 3 sites for the Hometown Recycling Day. There would be more information following.

Mr. Barbour noted that the noise ordinance pertaining to haulers may affecting dumping at the Transfer Station.
