Dear President Walker-Myers and Mr. Piscitelli:

Enclosed herewith please find a copy of the annual update of Yale University's Central/Science Campus Overall Parking Plan ("central/Science OPP"). This submission is made pursuant to the Order adopted by the Board of Alders on September 6, 2016 approving an amendment to the Central/Science OPP (the "Order") and consistent with the annual submissions made by Yale University (the "University") since the approval of the Central/Science OPP by the Board of Zoning Appeals in 1998. Pursuant to the Order, since no Central/Science OPP amendment has been requested or approved during the 2019 calendar year, the University hereby requests a resolution from the Board of Alders certi&i.ng that no amendment is required by this submission of the 2018 annual update of the Central/Science OPP. A draft resolution consistent with this request is enclosed.

Submitted herewith are copies of the following as of December 2018:

- Parking Inventory
- Student, Faculty and Staff FTE Counts.
- Yale Transportation Demand Management Overview
- Yale Shuttle Routes and Maps
- Yale Faculty, Staff and Student Parking Rates
- Overall Parking Plan Study Area Map

As you know, the Zoning Ordinance has for many years allowed educational and other institutions to provide parking through an overall parking plan. The purpose of a parking plan is to allow institutions with campuses to maintain a centralized parking supply with parking lots and garages in multiple locations that are available to serve buildings anywhere on the campus, and not subject to the standard requirement of the Zoning Ordinance that off-street parking be provided within 300 or 1,000 feet of each building. This recognizes, among other things, the inefficiency and lack of feasibility of providing separate parking at each individual building in a concentrated developed urban setting such as New Haven, the fluidity of a walkable and bicycle friendly campus environment and the provision of transportation options by the institution.

In the case of the University, the Central/Science Campus OPP allows parking facilities to be provided in multiple bicycle parking locations throughout the Central/Science campus and reflects the provision of shuttle service, bicycle parking and other sustainable transportation options within and around the campus to reduce vehicle use, traffic congestion and parking demand in the downtown and other areas of New Haven. The Central/Science OPP was approved by the Board of Zoning Appeals in 1998. The University has submitted to the City on an annual basis updates to the plan including changes to the parking inventory and population counts for students, faculty and staff. The most recent annual update was submitted on December 20, 2017, and provided to the Board of Alders. At its March 5, 2018 meeting, the Board of Alders adopted an Order pursuant to which it read and filed that update.

At all frnes since the University's previous annual submission, the University has continued to address New Entitlements in accordance with the terms of the Order. During the 2018 calendar year, the University sought and obtained resolutions from the Board of Alders that no Central/Science OPP amendment was required in connection with each zoning application proposing New Entitlements. There have been no changes to the central/Science OPP since the December 2017 submission to the Board of Alders which would require an amendment.

We also note the following: the University has been recognized as one of only two Best Workplaces for Commuters in the state by the National Center for Transit Research for offering transportation and benefits to employees to encourage a sustainable community. The University has also been actively implementing a Transportation Demand Management (TDM) program to reduce traffic on city streets and reduce demand on the parking system. Ongoing initiatives include:

- Yale Shuttle with extensive service to and throughout the Central/Science campus and between the central/Science and Medical School campuses. Over 1.8 million rider trips annually.
- The provision of approximately 2,750 bicycle spaces throughout campus to facilitate and encourage the use
 of bicycles.
- Distribution of shared-use bicycles through the "Noa" programs to Yale students, faculty, and departments for campus transportation.
- Access to over 30 shared vehicles for personal and business transportation through the Zipcar carsharing program.
- Discounted parking and guaranteed ride home for carpoolers.
- Guaranteed Ride Home Program and up to three free one-day parking permits per month issued to carpool
 and transit participants.
- West Campus Park & Ride.
- Yale-New Haven Hospital commuter lot park and ride for Yale employees.
- Commuter resources offered via the "Transportation Options" website: www.to.yale.edu
- Home mailing of transit passes, with pre-tax savings applied to the monthly cost.
- Recognition by the League of American Bicyclists as a Gold Bicycle Friendly University, one of only 20 in the country.
- Commissioned a sustainable transportation infrastructure study and has identified priorities for the first phase
 of implementing.
- Established a Bike-Walk committee that gets together quarterly to talk about how to enhance non-vehicular
 ways to get around campus.
- Created a bike map of campus that shows bike racks (open and covered), bikeshare stations bike repair stations, and shower facilities on and near Yale's campus. Map currently available at: https://to.yale.edu/bikerack-map
- Started quarterly meetings with other universities from the greater New Haven area to discuss sustainability broadly, but with transportation as a priority topic.

Beginning in February 2017, the University has actively participated in the newly-formed Transportation & Parking Working Group, which includes New Haven alders as well as representatives from the City of New Haven and Yale New Haven Hospital (YNHH). The group meets monthly and works constructively together to address any parking issues as well as to improve transportation and parking options.

WHEREAS: this issue came to our attention in August 2018, when the city refinanced \$160 million in bonds, adding a projected \$11 million to our city's debt repayment costs, and due to the current language in Appropriating Ordinance #3, the Bond Sale Committee, rather than the full Board of Alders, voted on the refinancing decision; and

WHEREAS: while we appreciate the time and care the three alders in leadership spent last summer deciding if they should approve the refinancing, we believe that a refinancing that will impose a long-term cost on all the residents of our City is something that the full Board has a responsibility to vote on; and

WHEREAS: we feel it would be appropriate to have a discussion about potentially returning the process to how it was pre-2008 when seeking approval of refundings with long-term costs.

The favorable report of the Legislation Committee recommending passage of the proposed ordinance amendment, as printed on pages of the Journal of the Regular Meeting of the Board of Alders held on December 16, 2019, was read for the second time.

Alder Santana: "Thank you Madam President. On Tuesday, December 10, 2019, the Legislation Committee heard this item and voted to amend it. The amendment included removing portions of Dixwell and Grand Avenues from the map change while keeping the specified portion of Whalley Avenue. The Committee also voted to remove the affordable housing components from the ordinance amendment. Committee members felt the issue of affordable housing would be more appropriately addressed in a comprehensive, citywide manner. This item proposes progressive zoning changes for the Whalley Avenue Commercial Gateway District, which should make properties in the area more marketable and encourage development. Many members of the public testified in favor of this change for Whalley Avenue. This amendment should remove barriers to the use of vacant storefronts and empty lots; boost local business and street level activation; and promote "green" buildings and durable construction. Finally, updating the zoning in this corridor meets one of the charges of the Comprehensive Plan, Vision 2025. The Legislation Committee voted to recommend this item, as amended, and I encourage our colleagues to support of this item. Thank you."

Alder Marchand: "Thank you Madam President. I wanted to rise and express my support for this item. I also wanted to just commend the City Plan staff on their intrepid efforts on this item. There has been public discussion of this zoning proposal more months, actually, it's been years. And it's been robust, and it's generated a lot of participation and a lot of interest and understandably so. This package of text amendments is ambitious in a number of ways. It pushes the envelope in terms of zoning on the issue of deciding standards on the issue of creating design on the issue of density and new urbanist principles. This is a very good package of changes. It's worth noting again that representatives from organizations along Whalley Avenue and residents along Whalley Avenue pretty much unanimously through the process expressed their strong support for this and their sense that this kind of change was overdue and would help to move them forward. I just wanted to emphasize that the Committee recommended to take the affordability items out of the text amendment because we felt that it would be better to wait until after the inclusionary zoning study, and to wait for a more citywide approach in terms of zoning towards encouraging and incenting the development of affordable housing. I just wanted to make sure that the public understands that this body and certainly the Committee continue to see the issue of affordable housing is a priority but felt that rather to do a small-scale pilot with this one community district it would be better to wait for the citywide approach, and I think that's worth repeating. So again, I rise to support this and I thank the efforts of this staff for working very hard on this, and I thank all the residents from all the different neighborhoods involved for coming to the meetings and participating Thank you Madam President."

Alder Winter: "Thank you Madam President. This ordinance amendment contains important incentives to encourage green building practices such as mass timber construction that can sequester carbon and create local jobs. Carbon emissions from building new buildings continue to grow in our country. We can help reverse that trend and build our local economy with these important provisions. I urge my colleagues to support this. Thank you, Madam President."

Alder DeCola: "Thank you Madam President.

Thank you, Madam President, on Thursday, December 5, 2019, the City Services and Environmental Policy Committee met, and we would like to favorably recommend this item. The committee heard from Coach Thompson's family and community members who Coach Thompson had mentored over the years as a coach of the New Haven Age Group Track Club. I urge colleagues to vote favorably to support this corner naming. Thank you, Madam President.

On Thursday, December 5, 2019, the City Services and Environmental Policy Committee met, and we would like to favorably recommend this item. This grant will allow the city to complete environmental assessments and clean up

properties in the River Street Municipal Development Project Area to make these properties more marketable. I urge colleagues to support this grant.

This is the second piece to the abandonment of Waterfront Street. It was determined in the first hearing that Safety-Kleen would need to complete an easement for the City of New Haven to give the City continued access to the property under limited circumstances, before the City could finalize the abandonment of Waterfront Street to Safety-Kleen. Safety-Kleen worked with Corporation Counsel and submitted this easement to the Board of Alders for approval. The easement as submitted and approved by Corporation Counsel meets the City's requirements for future access. I urge colleagues to vote favorably to support this item.

If approved by Congress, this Act is expected to reduce 40% of America's emissions in the first twelve years. The Act would work by setting up a tax at the source of fossil fuels. These funds would then be refunded to taxpayers in the form of tax credits based on the taxpayers' own emissions. The taxpayers with lower emissions, usually the most vulnerable, would receive larger credits. This Act would make environmentally friendly energy like wind more cost effective – leveling the playing field. I urge colleagues to vote favorably to support this item. Thank you, Madam President."

Alder Morrison: "Thank you Madam President. I rise in support of the corner naming of Coach William Thompson Way. You can say so many things about Coach Thompson. The location of this corner naming is the most appropriate location, because Mr. Thompson has trained children for nearly fifty years. And the reason why that corner is so important is because that is the place where he sat every single day until the last child left. As you know, sometimes people can be late, or people cannot come at all. But Mr. Thompson, he was committed to the children, he was committed to the families, and he taught integrity to the point that his children have been okay with giving all of us their dad. I didn't run track at all, but my sister did. And for her to be a part of that track family, that is a family. And so, I ask my colleagues to please support this item, because Coach Thompson he wouldn't have any other way. Knowing him, he would say, 'No, don't do that for me.' But need to do that for him because he has really shown love to our children and has really helped to grow up our city. Thank you."

Alder Roth: "Thank you Madam President. I support all the items, but want to speak to item d. The global climate crisis is unfortunately very real. It therefore is exciting that this bill, which would have a significant impact on reducing carbon emissions, has a chance of actually passing. It was impressive at the CSEP hearing to learn how advocates are encouraging cities throughout the country to support resolutions like this. So, I view this as more than a feel-good exercise, but an opportunity to join other cities nationwide telling Congress we need to act now to reduce carbon emissions and save the planet. And perhaps it will encourage the New Haven delegation to shift from being supporters the legislation, which of course is great, to sponsoring it, which would give it more momentum. I encourage my colleagues to support this important resolution. Thank you."

Alder Hamilton: "Thank you Madam President. I also stand in support of the item for Thompson. He was an excellent mentor in our community. My son is a track runner. Mr. Thompson has always been there for all the youth of our community. I ask the colleagues to support this item. Thank you very much."

Alder Roth: "Thank you Madam President. Thank you, Madam President. Both of my parents had serious neurological diseases, which caused them to be dependent on wheelchairs at the end of their lives. From this experience, I appreciate the stress involved with getting someone with mobility limitations to medical appointments, which already are stressful. I therefore support YNHH building walkways from garages to the hospital, which will at least make that element of a difficult experience easy for patients and their families and encourage my colleagues to support this. Thank you."
