In accordance with the Order of the Board of Aldermen authorizing the Mayor to apply for and accept all grants on behalf of the City of New Haven, passed October 17, 1994, I am respectfully writing to advise you of an application by the City of New Haven's Department of Police Service to the State of Connecticut Office of Policy and Management for a \$ 195,000.00 grant to reimburse the department for overtime for COVID-19 mitigation and response efforts, including using strategies to reduce violent and property crimes during the period August 9 through December 31, 2021.

As of August 1 8, there has been a 76% increase in shots fired and 20% increase in homicides when compared to the same period in 2020. There has also been an uptick in shootings connected with stolen cars, most of which involve juveniles. These increases are the result of factors related the pandemic: the release of certain prisoners from prison, battles for drugs and territory and other unresolved conflicts, stresses of unemployment and being cash-strapped, and limited job and summer opportunities for youth. Domestic violence calls are increasing again as formerly housebound victims reach out for help. We propose to use the overtime funding for both patrol and investigations, with special focus on situations involving crime guns, youth crime (especially stolen cars), street racing, prisoner re-entry, and victim advocacy. More patrol walking and bicycle beats will be scheduled, with officers handing out "Protecting the Community" cards in English and Spanish to residents that list resources for medical, mental health, housing, and food programs. We are requesting consideration of unanimous consent due to the time constraints for enforcement activities. A similar program-- LM2020-0482—was approved by the Board in November 2020.

Transportation (CTDOT) and, by extension, a new partnership to deliver best-in-class development along the Northeast Corridor.

By way of background, the City and CTDOT have been working to expand economic opportunities and customer amenities within Union Station; develop additional appropriately sized parking facilities for the Campus; and to more fully develop transit-oriented development around Union Station all in a manner consistent with the Hill to Downtown Community Plan and various state level transportation plans.

In September 2020, a letter of intent set forth this vision with specific goals to develop a 600-space parking facility, an intermodal center for local and regional bus users and renovations to Union Station. Together with goals connecting Union Station and State Street Station to the overall development of the surrounding area, city and state planning teams have been collaborating on a regular basis, not only on the lease document but also on implementation steps. The recent reopening of Columbus Avenue from Church Street to South Orange Street as well as a plan to extend a separated cycle track over the Amtrak bridge at Water Street are attributed to these meaningful collaborations.

This note is to advise the Honorable Board of Alders that the Department of Police Service seeks to execute a 5-year contract with Taser/Axon for body-worn cameras (BWC) and tasers and seeks to purchase and install dashboard cameras and make upgrades to Interview Room equipment. The 5-year contract period is from 2021 through 2026, and will cover hardware, software, and network/installation costs for BWCs, tasers, dashboard cameras, and interview room equipment.

The 5-year cost is \$5,740,000.00. The Year One cost of \$3,004,800 to be paid from the police capital fund budget covers hardware, installation/set-up costs, and one year's worth of Taser cartridges, training vouchers, and software. The balance of \$2,735,200 will be paid in Years Two through Five from the police general fund and IT general fund budgets: the police budget will pay for Taser cartridges and training vouchers and the IT budget will pay for annual software and maintenance expenses.

The hardware included in this contract is as follows:

- 147 Axon Fleet 3 Dashboard Cameras with a refresh at the end of 5 years. A "refresh" is when we obtain replacement equipment of either the same model or the most current model, ensuring that we are always using current technology within useful life. This camera provides seamless integration with the Department's BWC program and Evidence.com.
- 5 Axon Interview Room Upgrades (4 Investigative Services Unit and 1 Internal Affairs), which will live-stream and ingest interviews into Evidence.com for digital evidence management. Video quality will be improved for use in prosecutions.
- 800 AB3 BWCs with 2 refreshes over the 5-year contract period, enabling us to continue our two-camera system to best ensure a charged camera at all times.
- 25 Flex 2 BWCs for SWAT to better mount to their gear, including refreshes.

- 350 T7 Tasers and corresponding cartridges to cover training and deployment replenishments for the 5-year contract period. This dual cartridge system includes signal activation of BWCs.
- Taser training vouchers to cover training certification requirements for the 5-year contract period.

The software/IT included in this contract is Evidence.com. The following products will be included in the negotiated price if the contract is approved by September 30, 2021:

- Axon Response for Devices: This technology brings real-time situational awareness features
  like live maps and streaming to our connected devices. It helps officers and command staff
  maintain visibility of developing situations, obtain and share information as it emerges, and
  send help as needed.
- Axon Performance: This technology automates BWC reviews and provides actionable, up to
  date compliance information, such as camera use during calls for services, with an intuitive
  metrics dashboard and sharable reporting capabilities. The service extracts patterns of behavior
  from our Evidence.com data to improve agency review processes, guide policy updates, and
  identify opportunities for officer training and development.
- Axon Redaction Assistant: This technology uses automation to identify and mask the most common objects and personally identifiable information found in video evidence such as screens, faces, and license plates from BWC, in-car, and interview room video. With autoredacted video, users can focus on more complex work.
- Axon Citizen for Communities: This technology will allow us to engage the community in
  efforts to investigate crimes and preserve public safety. The Department will be able to launch
  public portals from Evidence.com to collect digital evidence submissions from the public,
  which are screened for viruses and categorized automatically, enabling us to review potential
  evidence files safely and quickly.

Connecticut Public Act 20-1, An Act Concerning Police Accountability, established on October 1, 2020, mandates the purchase and deployment of BWCs and dashboard cameras in all police departments by July 1, 2022. The Department established its BWC program in 2017 with the vendor Taser/Axon. It is noteworthy that the State of Connecticut Office of Policy and Management offers a 50% reimbursement to distressed municipalities—of which New Haven is one--for the first-year costs for implementing the dashboard camera program, estimated at up to \$650,000.00. In order to be eligible for the reimbursement, the cameras must be purchased by December 31, 2021.

On behalf of Fusco Harbor Associates LLC and Fusco Maritime Associates LLC (collectively "Fusco"), we are pleased to submit the attached petition and materials for a zoning amendment to modify Planned Development District ("PDD") #53 (the "Petition or Application") and corresponding Coastal Site Plan Review ("CSPR"). The Petition requests modification of the existing PDD #53 to expressly allow residential use up to 500 apartments in the Long Wharf area between the Maritime Center and the recently added Canal Dock Boathouse.

This portion of the Long Wharf area is one of the most visible locations in the City and often the first impression visitors have of New Haven. It has been the subject of significant planning for

growth, improving public access to the shoreline, and establishing a residential presence to make the area more inviting including most recently a two-year study culminating in the development of the Long Wharf Responsible Growth Plan in 2018 (which was formally adopted by the Board of Alders as part of the New Haven Vision 2025 comprehensive plan (hereafter the "Vision Plan"). The Vision Plan characterizes the Long Wharf area as underutilized and recommends "denser development of new residential and commercial uses." (Vision Plan p. 11). It calls for the development of five new walkable, mixed-use neighborhoods including a residential "harbor district" located in the area of PDD #53. The Vision Plan was the

result of extensive City, State, and community input and took into account City goals for economic development, shoreline access, and coastal resiliency. Fusco's proposed plan is the key first step in acting on the City's Vison Plan for the Long Wharf area.

Fusco's proposed plan is consistent with and adopts many of the goals of the Vision Plan. Importantly, the proposed modification of PDD #53 will provide a critical mass of residences on site and create a destination for New Haven residents and others to visit the shoreline. The mixed-use amenities will create a synergy and direct connection with the boathouse, Long Wharf Park, and the Hill South and Downtown neighborhoods. People will have more options; they can meet for a walk or bike ride, visit with friends and family, shop in the market, enjoy a meal or potentially some live entertainment, or just sit and enjoy the harbor.

Fusco takes great pride in New Haven and the Long Wharf area. It built and maintains the Maritime Center (Fusco's headquarters) and has developed a number of New Haven's other landmark sites. The Maritime Center stands out as an attractive, well-maintained presence in an area otherwise dominated by industrial uses and surface parking. Fusco is excited for the opportunity to grow Long Wharf with the same caliber of development and desirable amenities as detailed in this proposal. Historically, Long Wharf was a key area for the City and city life and it can be again. For this project, Fusco has assembled an expert team of architects, landscape architects, and engineers to re-imagine what our shoreline can look like and how to invite our neighbors to this area.

With these materials, we are delivering a check for the application fee of \$1,500 for a zoning text or map change on the basis that this is a change to PDD #53. If any additional fee is required or we have miscalculated the fee please let me know and we will provide a check for the additional amount.

We look forward to the opportunity to present Fusco's proposed plan to revitalize this portion of New Haven's shoreline to the Board of Alders and working with City staff at its earliest opportunity.

WHEREAS: certain responsibilities will be transferred by the Authority to the private investor in a sublease from the Authority for a portion of the premises leased by the Authority, said responsibilities always to be subject to the statutory authority of the Authority and, to the extent applicable, the City as owner of the land on which the Airport is situated; and

WHEREAS: the City's General Ordinances Section 4-70, which pertains to the weight of aircraft flying in and out of the Airport is inconsistent with regulations of the Federal Aviation Administration; and

NOW, THEREFORE, BE IT ORDERED, by the Board of Alders of the City of New Haven that the Amended and Restated Lease be approved together with any other documents that are reasonably required to implement the provisions of the Amended and Restated Lease and/or this Order; and

WHEREAS: pursuant to Article XIII, Section 2E of the Charter, the Board of Alders referred the Petition to the New Haven City Plan Commission for a public hearing; and

WHEREAS: on, 2021, the City Plan Commission held a public hearing on the Petition after providing due notice of such hearing in accordance with the provisions of law; and

WHEREAS: on, 2021, the City Plan Commission rendered an advisory report to the Board of Alders after considering the factors set forth in Article VII of the Charter and Sections 64(d)(2) of the Zoning Ordinance recommending approval of the Petition, CPC Report No.; and
