RE: Ordinance Amendment to Appropriating Ordinance # 1 for the reclassification of position title within the Health Department

Dear Honorable President Walker-Myers:

As required by City charter and general code of ordinances, an ordinance amendment to appropriating ordinance #1 is required when one of the following occurs.

- 1. Reclassifying and addition of positions in the fiscal year 2021-22 budget
- 2. Transferring funds from expenditure reserve account to the Office of the Assessor, Office of Corporation Counsel, Commission on Equal Opportunity, and New Haven Public Library.

The Health Department, Vital Stats division is seeking <u>unanimous consent (UC)</u> to reclassify the vacant titles of processing clerk (#760) and processing clerk bilingual (#790). The combined salary budget for both positions is \$91,164. While positions normally go through the committee process due to budgetary changes, there should be no budgetary increase for the positions. Vital Stats is simply looking to change the position titles only (create new position# in the budget). The Department is not anticipating the hires going above the combined salary budget for the two positions (within bargaining unit promotion rules for internal candidates do apply as normal).

The Vital Stats Office is a customer service facing office which has one of the highest foot traffic count in City Hall. Since City Hall re-opened to the public the security guards have been keeping track of who enters the building and where they are going. The data clearly shows that when public comes to City Hall the Vital Statistics office sees more than double of what every other office sees combined.

The Vital Statistics Office is a small staff that processes over 300 documents daily. The documents processed range from all birth, death, and marriage records to elm city id card. Each staff member processes approximately 75 - 100 certificates a day.

The Office relies on having the appropriate number of personnel and being able to run efficiently for the residents of New Haven

The change in this position is vital to operations of the office. The Vital Statistics office consist of 3 clerks and the Registrar. However, in the last few months, the office had one clerk retire, and clerk (bilingual) suddenly resign without notice. This has put a huge strain on the remaining personnel and the Registrar.

The position would create new opportunities in office efficient and operation. As an example, per CT State statues, only Registrars and Assistant Registrars are the only position that are certified and can officially process a marriage license for a couple to be married in the City of New Haven by giving the couple an oath. Currently, the Registrar is the only position that can sign various documents for residents in New Haven.

The new position of Assistant Registrar will also be required to have that certification to provide the oath for marriage and be able to assist the Registrar with various duties that the current position of processing clerk cannot per CT state statue. This will allow a smoother workflow in the office and not cripple the office if the Registrar is not present for any reason. This change is key for Vital Stats to have at least 4 staff working in the office to run efficiently.

As mentioned above, The City is asking for unanimous consent (UC) as this change is title only Processing Clerk to Assistant Registrar: The position would be within the same bargaining unit (884) and the same range (8) and step based on, the already approved GF budget.

Having the title Assistant Registrar, rather than Processing Clerk, would mean that the new employees could sign off on the marriage licenses, provide an oath to couples and other documentation as needed. The current structure limits the office and the working capacity of the Registrar, as well as the department.


