Meeting opened at 12:37 pm P.M.

**#1 List Removals**

Ms. Marcano then presented the list of names recommended for removal from list #21-01E Police Officer. The reason for the removal of each candidate was cited by each name.

Commissioner Rodriguez moved to approve the removal of names from list #20-01E Police Officer as presented. Seconded by Commissioner Negron. Votes taken, all yeas; none opposed, no abstentions. Removals for list #21-01E Police Officer approved.

Commissioner Daniels moved to approve the removal of names from list #20-01E Firefighter as presented. Seconded by Commissioner Rodriguez. Votes taken, all yeas; none opposed, one abstention from Commissioner Mongillo. Removals for list #20-01E Firefighter approved.

**#2 List Extensions**

Ms. Marcano explained the need for an additional list extension for list #21-01E Police Officer by another month because the Police Department is trying to hire as many individuals as they can before list expires or expires, and before certifying the new list.

Commissioner Rodriguez moved to extend list #21-01E Police Officer for a period of 30 days. Seconded by Commissioner Daniels. Commissioner Negron asked a question regarding certifying lists for a two-year period, which Ms. Marcano answered, explaining that it makes sense to certify lists for one year, and then later determining if a list needs to be extended as needed. Votes taken, all yeas; none opposed, no abstentions. List extension for list #21-01E Police Officer approved for an additional 30 days.

There being no more business to conduct, Commissioner Daneils motioned to adjourn; seconded by Commissioner Negron. All yeas. Meeting adjourned at 12:55 pm.
