A. Jefferson discussed departmental plans for 2022:

Cultural Equity Plan – Staff has confirmed board of alder approval was not required prior to formal plan release. The plan will go live online and launch 11am on January 13 outside the Q-House. 1000 hard copies and bookmarks have been printed, additionally available online. Distribution will include New Haven branch libraries plus over 100 non-profit and community service organizations. P Dunn will speak on behalf of the CAC at the event. The plan will be workshopped throughout the city during the year to get ongoing feedback.

Arts for Anti-Racism: January 19 will host GARE - members. A. Jefferson sits on core equity team within city. GARE provides the city tools for furthering workplace equity.

Internships: A couple departmental internships for marketing/social media and arts for anti-racism are open and staff is currently interviewing. The internships are supported through NHFI.

Grants Received: \$100k Workplace Initiative in collab from the Arts Council and continue 6-week free Entrepreneurship Decoded training program. \$118k from Cultural Fund, \$10k Tremaine for CEP marketing

ARP: grant funding may potentially reopen in the Spring with additional funds if available

Public Art: continuing to update data on the national publicartarchive.org. This year the department in collaboration with NuSpiral will unveil 2-3 murals in city underpass locations.

Increase promotion of current programming like film, neighborhood cultural vitality

Internship program outside of the workforce program. Building a foundation with more local organizations

A. Jefferson discussed developing an events team to support staff, perhaps stipend based to support departmental/city activities
